LEGISLATIVE REPORT

H. 3768- SC Able Savings Program

On December 19, 2014, President Obama signed into law the Achieving Better Life Experience (ABLE) Act. The ABLE Act will allow people with disabilities (with an age of onset up to 26 years old) and their families the opportunity to create a tax-exempt savings account that can be used for maintaining health, independence and quality of life. These accounts resemble the 529 college-savings plans and will allow people with disabilities to save as much as \$100,000 and still qualify for benefits such as Medicaid and Supplemental Security Income (SSI).

South Carolina is among the states that have already started the authorization process that will enable South Carolina residents to take advantage of the new 529A accounts. The legislation was introduced into the SC House on March 3, 2015, and the SC Senate on May 4, 2015. With approval from the South Carolina Bar Board of Governors, the Elder Law Committee forwarded their suggested amendments to the General Assembly.
