

Dear Mr. Soura,

As the contractor for the Jurisdiction C Durable Medical Equipment Medicare Administrative Contract (DME MAC), we are advising you of the fee schedule changes that will be made based on the July Quarterly Update for 2015 Durable Medical Equipment, Prosthetics, Orthotics and Supplies (DMEPOS) Fee Schedule. These changes will be implemented per Change Request (CR) 9177 from the Centers for Medicare & Medicaid Services.

Effective July 1, 2015, the fee schedule amounts for HCPCS codes L7900 and L7902 have been removed from the DMEPOS Fee Schedule.

The July Quarterly Update for the 2015 DMEPOS Fee schedule includes fee schedule amounts for HCPCS code A4602NU. These fees are effective for date of service on or after January 1, 2015. The following are the fee schedule amounts for the states in Jurisdiction C.
