Hi Chad, Emerson, Howell, and Bill,

Attached are updated tables and comments for September collections. Since my last email, the CG revised the monthly figures and included the payment for Unclaimed Property which we had previously noted. Also, after further review and discussion with DOR, we learned that the normal refunds for the tax credits were actually issued. So, we do not have to note a pending adjustment to the revenue and which also means that revenue is in a little better shape than previously noted. The attached basically covers the information for the morning session; no action is needed or expected at the morning session.

For the afternoon regional meeting, we will be sending you a couple of documents. One, we will be sending Robert's book full of background materials. We expect to send this overnight either Wed or Thurs so you will have it before the weekend.
