Tony and Sue,

“Quick” summary for the week.

AIM

June PRFs

- Central Midland’s June was close and we are going to accept what they have submitted.
- Appalachia is asking for quite a bit less than what is in AIM for III E year to date.
- Upper Savannah is asking for too much in some lines and not enough in others for June.
- We will get together with Ruchelle and go over Appalachia and Upper Savannah to make sure the numbers are correct.

July PRFs

- Catawba, Santee-Lynches, Pee Dee, Waccamaw, and Lower Savannah July PRFs have all been approved by me from an AIM/IT perspective.
- Trident made a correction in August, but asked for less in July. I rejected it.
 ☉Trident must leave the July request alone and catch the dollar change in August.

Dwayne has made the changes to the table to track C1 and C2 NSIP separately.

- Paula will modify the MUSRNSIPiib-dm to show the separate tracking.
- This and making sure August is working properly will take some effort.

Some reports will need to be tweaked to properly access historical (FY14 and before) data.

Procurement

Have the three required quotes for the backup appliance. About \$4400.

Paula is going through the maze to get a Powerbuilder quote. About \$2,7000 per user (2), but there may be a discount.

- Powerbuilder allows us to write, test, and manage reports a lot better.
- It is on state contract so we do not need three quotes.

Building purchase requisition for cables, cords, and power strips – under \$100

Once the Surface Pro passes first muster, the docking stations need to be procured.
