### Governor Nikki Haley News:

**The State:** Nikki Haley calls proposed broader ethics commission a 'poison pill'

Gov. Nikki Haley opposes a House panel's proposal to add oversight of state judges to an enlarged ethics commission, calling it a "poison pill" to sweeping reform proposals. In a letter sent to House members Wednesday night, Haley said she approved the move to end having legislators police themselves with their own ethics committees.

**Note:** "I believe adding a brand new, controversial element at this stage of the legislative process to a well-debated issue will only serve as a 'poison pill' rather than a sincere effort to fix the problem," Haley wrote. "I ask that the House and the Subcommittee members re-evaluate their independent investigation proposal. It will stymie our ability to give the people of our state what they want and what they deserve this year."

State agencies own far too much property in South Carolina, and much of it should be sold, Gov. Nikki Haley said Wednesday. The first statewide inventory of property in at least a decade shows 109 agencies own nearly 12,300 pieces of property, said Budget and Control Board Director Marcia Adams.

**Note:** "I want to see how much is actually being used. How much is empty? I want to see what we're using it for," Haley said. "This is just a no-brainer. This money does not need to be tied up because somebody forgot they own it."

The Senate passed a bill Wednesday aimed at boosting students' chances of success through an expansion of 4-year-old kindergarten and early intervention in reading. Senators voted 36-6 on a compromise of the "Read to Succeed" bill, which united the agendas of the chambers' Republican and Democratic caucuses.

**Note:** As for the reading piece, the bulk of that funding is already in the House's budget plan, which adopted Gov. Nikki Haley's education recommendations.

Emma's Law is headed to Gov. Nikki Haley's desk. The Senate passed unanimously the House's version of the law Wednesday that requires alcohol breath testers installed in cars for some offenders convicted of drunk driving for the first time. State Sen. Joel Lourie, a Richland Democrat who was the bill's main sponsor, was happy to see the measure go to the governor after needing a year for final passage.

A bill that would expand 4-year-old kindergarten across the state, if lawmakers choose to pay for it, and create a statewide reading program in public schools aimed at getting third graders reading on grade level now moves to the S.C. House after the Senate approved the bill Wednesday.

**Note:** Those programs also have the backing of Republican Gov. Nikki Haley, who introduced a sweeping education plan before the legislative session this year.
