Dear Ms. Johns:

I appreciate your letter of April 8th concerning Dr. Johns' appeal. There are several things you must know. Dr. Johns has until April 29, 2010 to file his appeal. The appeal must be made in writing – not by fax, not by email – to Mr. Vastine Crouch, Director of the Division of Appeals and Hearings. To appear *pro haec vice*, you must comply strictly with Rule 404, Appellate Court Rules.

Once again, your understanding is incorrect. Ms. Forkner is not reviewing the issue of payment for VEP testing. The Department will not pay for this test if it is used as a screening. Once a screening has taken place and a physician has a medical reason for VEP use, and documents the medical necessity for using VEP, the Department will make payment.

If I can be of assistance to you, let me know.
