Elisabeth –

On behalf of ACT, I would like to offer a thirty day extension to the SCWRC contract. Based on conversations that you and I have had, I recognize that sites were not able to begin testing until August.

We have experienced delays based on sites not replying to mutual termination dates and incorrect contacts. Please let your team know that these have impacted our ability to set up sites.

As of August 19, fifty two sites have been set up and are able to conduct testing. The majority of these sites are WSP and Adult Education – private sites. We are working on the 82 applications from the first enrollment window and 42 from the second window. Additionally, SC Vocational Rehabilitation replied today regarding a mutual termination agreement which will allow us to move forward on these sites.

Please know that I have taken your comments and concerns and shared them with appropriate colleagues. We want this to partnership that is open to on-going communication about processes that meet the needs of our customers.
