A CALLED MEETING OF THE ANDERSON COUNTY COUNCIL WAS HELD IN THE CONFERENCE ROOM ON THE THIRD FLOOR (ADMINISTRATOR'S OFFICE) ON APRIL 22, 1986 AT 5:00 P.M. COUNCIL WENT INTO A WORKSHOP MEETING AT APPROXIMATELY 6:00 P.M. CHAIRMAN HAROLD E. BEEBE PRESIDED.

Mr. Beebe called the meeting to order and Councilman David Hooper gave the invocation.

Mr. Cox explained that the meeting was called to be a workshop meeting to discuss the budget for Solid Waste; but moved that Council go into special session to discuss the Accommodations Tax revenue. Mr. Rhodes seconded and vote was 5-0.

Mr. Stephen Crawford and Mr. David Watson discussed the Recreation Commission's share of the Accommodations Tax monies. An ordinance was introduced (Ordinance #198- Amendment #3 to the 1985-86 Budget) for Council's consideration. It has been estimated that the County will receive \$32,000, of which \$7,000 would go to the Pendleton Historic & Recreation Commission (25%). In order to appropriate this money for the Recreation Commission, an amendment to the adopted budget would have to be approved. After some discussion, Council agreed to place \$6,000 in account #801-185-210 for the Recreation Commission (direct assistance) by first reading approval of Ordinance #198. Two additional readings would be required. This would be for now until July 1 at which time the new budget would be adopted. Mr. Cox moved that Ordinance #198 be approved on first reading for the \$6,000 appropriation. Mr. Hooper seconded and vote was unanimous.

Council heard from concerned citizens.

Mr. Wiles moved to go out of special session into a budget workshop (approximately 6:00 p.m.) to discuss the 1986-87 budget for Solid Waste. Mr. Cox seconded and vote was unanimous.

Council adjourned at 6 p.m.
