Currently there are only 105 CFWEs worldwide: **93 in the US, (78 in public Crime Labs, 15 in private practice) and 12 in other countries.**

- 21 States do not have any CFWE's (0)
- 5 States only have 1 CFWE (5 public labs)
- 13 States have 2 CFWE's (26 total - 21 public labs / 5 private practice)
- 12 States have more than 2 CFWE's (62 total - 53 public labs / 9 private practice)

2. Does your caseload justify the costs associated with training someone to competency and ultimately certification?

Currently many labs are experiencing minimal footwear submissions. This is usually driven by crime scene


