Yeah, we pitched \$75M for the Highway Turnback Initiative this year and got \$0 in the budget. There are significant transportation needs generally - for bridge renovation and replacement, especially. And the feds will likely only be reducing their support for transportation infrastructure, going forward. The federal highway trust fund is essentially insolvent at this point.

For tax relief, she pitched \$140M this year, between business and individual tax cuts. In the end, we got a deal that will ramp up to \$65M over three years.

She'd like to do more for charters and for school choice...it's easier to sell choice if the legacy schools don't feel like they're being shortchanged in the process. So that one's less readily quantifiable, but there's a financial component to that, too.

The higher ed initiative is ABF - Accountability-Based Funding. We got it out of the Senate, but it died in the House. It doesn't necessarily require more money, but there's a financial piece of that, since you have the usual winners/losers debate...and there are institutional grudges still over the last two overhauls of their funding formula.

Pre-k, roads, higher ed, tax relief? We budgeted \$66 million state on natural enrollment growth and inflation alone this year.
