Chip,  
Sorry for the delay. I have attached several amendments and an updated side-by-side of the SC Ethics Reform Commission (SCERC) recommendations and the Senate ethics bills. I have shaded the recommendations in the side-by-side which indicate the amendments I have drafted. This is my initial stab at drafting the amendments and Senate Judiciary staff or Legislative Council may have a better way to do it.

I have not yet drafted an amendment regarding the "enhanced" State Ethics Commission and how to devolve powers

of the House and Senate Ethics Committees. A House bill (H. 3772) was introduced last week that would create a re-constituted State Ethics Commission and give it (and a Public Integrity Unit) all investigative authority and leave adjudicatory authority with the legislative committees. I am happy to discuss this issue with you further as I know it is a very important part of the ethics reform legislation that we hope will be addressed in Subcommittee.
