Spoke with Ray this morning to catch up with him on his plan. He's great, and I think the LG will enjoy meeting him. They have a center downtown Myrtle Beach (near the vicinity of where Highways 501 and 17 meet. He said the LG would be welcome to stop by there if he would like. The Carolina Forest center, which is on the way to Conway, is not one of their better ones. The Conway center is another option (unless he wants to say a quick "hello" at the one downtown as he passes by on the way to the Conway center). At the Conway center, he can meet folks, tour the center, and go on a meal delivery route (2-3 stops in the Conway area) with the person who handles their VIP program, a senior citizen veterans program. I just need to know a time to tell him the LG will be there and a time he would need to leave, based upon your other meetings; everything else is squared away. If it was up to me, I would say meet with the sheriff / staff right after lunch if possible. That way it would be 8:30a - 9:30a private meeting; travel time; 10:00a - 12:00p (or close) for center visits and meal routes... Keeping in mind that seniors do like to talk when he stops by); and time for him to grab a quick lunch before his next commitment. Here are their locations and info:

I've been in the longest staff meeting ever and I tried to escape to call Ray Fontaine, Executive Director of the Horry County Council on Aging, before lunch. However, he had just left when I called due to attending a funeral at 1:00p. I wanted to make him aware that the LG would be in town next week (as a courtesy) and also see if he had any suggestions as to what site would be best, based on their activities as well as the LG's travel route between meetings.
