AGREEMENT FOR CONSULTANT SERVICES

The Department requests Commission approval to advertise for and select a consulting and engineering firm for the purpose of entering into an agreement to provide engineering services for multilaning S. C. Route 72 from I-26 southerly to U. S. Route 221 in Laurens County. The proposed project would encompass approximately 21 miles.

The scope of work will involve preliminary engineering and the development of final right of way and construction plans.

Funding for this project will be "A Strategic Highway Plan for Improving Mobility and Safety (SHIMS)".

North Augusta Building Lease - Recommendation to Terminate Lease

It is recommended that this Department implement recommendation of the Capital Improvements Committee by terminating lease with the City of North Augusta for building which is not needed for any function of this Department. The building has been under lease for \$1.00 per year, to expire in the year 2006. It has been confirmed that neither Maintenance, Right of Way, Patrol, or MVD has any use for the building, which is owned by the City of North Augusta. The Department presently has maintenance obligations on the building, and must pay insurance premiums for any on-premise liability exposure. The lease was obviously an accommodation from the City of North Augusta, but the cost of maintaining the property under lease, including insurance against liability, outweigh any reasons for retaining the leasehold interest, in that no division within the Department has any need for the building.

It is recommended that the Commission approve termination of the lease, based upon the recommendation of the Capital Improvements Committee's special meeting of October 27, 1988, as further recommended by this office. It is anticipated that the lease can be terminated without any liability on the part of the Department, and that will constitute a condition of this recommendation.
