Project Background

The National Association of States United for Aging and Disabilities (NASUAD) is the membership organization for state aging and disability directors. Since 2012, NASUAD has been working in collaboration with Human Services Research Institute (HSRI), a non-profit research firm whose mission is to improve the lives of people with various disabilities, their families, and caregivers, to build the National Core Indicators-Aging and Disabilities (NCI-AD). NCI-AD is an initiative designed to support states' interest in assessing the performance of their programs and delivery systems and improving services for older adults, individuals with physical disabilities, and their caregivers. Like the intellectual/developmental disabilities (I/DD) service system's National Core Indicators (NCI), NCI-AD's primary aim is to collect and maintain valid and reliable data that give states a broad view of how their publicly-funded long term services and supports (LTSS) impact the quality of life and outcomes of service participants.

NCI, which began in 1997, was a collaborative project between HSRI and the National Association of State Directors of Developmental Disabilities (NASDDDS) that focused on the performance of public I/DD service systems. NASUAD's members had been interested in developing a tool similar to NCI for years and in 2012, after discussing the success of the NCI project internally and with HSRI and NASDDDS, NASUAD's Board of Directors voted to begin work on the NCI-AD project. In June 2013, NASUAD and HSRI, with help from the NCI-AD steering committee (comprised of NASUAD board members) and NASDDDS, began amending the Adult-Consumer Survey portion of the NCI tool to better align with the priorities of aging and disability service users and systems. In September 2013, these groups met again to discuss and amend the first draft of the survey. Over the next four months, the survey went through a series of seven revisions based on feedback gathered from the steering committee, stakeholder groups, national-level partners, focus groups comprised of older adults and individuals with physical disabilities being served by their state systems, and a pre-pilot test with service participants in Maine. The Muskie School at University of Southern Maine was also instrumental in both drafting of the survey and facilitating and conducting the pre-pilot test.

Data for the project are gathered through yearly in-person consumer surveys administered by state agencies to a sample of at least 400 consumers of LTSS. The sample will include older adults and individuals with physical disabilities accessing publicly-funded LTSS through nursing homes/skilled nursing facilities, Medicaid waivers, Medicaid state plans, and/or state-funded programs, as well as older adults served by Older Americans Act programs.

Some of the benefits of NCI-AD include:

- A focus on how consumers experience services and how services impact their quality of life;
- A focus on performance of state LTSS systems instead of specific services;
- Obtaining data on LTSS services regardless of funding source (Medicaid/non-Medicaid/Older Americans Act) or setting;

- Gathering information directly from randomly-selected consumers through face-to-face interviews;
- Usefulness in meeting CMS waiver quality assurances and assessing performance of MLTSS contractors;
- State-to-state, regional, and cross agency/service comparisons; and
- Provision of timely and actionable data over time that can be used for system improvement.

NCI-AD brings an important value proposition to the field of aging and disability services through knowledge development on indicators and outcomes that assess quality of life, community integration, and person-centered services. This knowledge development will help to address long-recognized gaps in measuring indicators and outcomes in LTSS service systems that go beyond measures of health and safety to address important social, community, and person-centered goals.

The Instrument

The NCI-AD Consumer Survey instrument includes a background section, which gathers data about the consumer from agency records, and the actual in-person survey. The in-person survey includes subjective satisfaction-related questions that can only be answered by the consumer, and objective questions that can be answered by the consumer or, if needed, their proxy. The survey also includes an interviewer feedback form to capture interviewers' experiences conducting the survey and to solicit their feedback on any questions/wording that were consistently problematic.

Pilot

Three states volunteered to pilot the NCI-AD Consumer Survey – Georgia, Minnesota, and Ohio. In early 2014, the three states began piloting the NCI-AD Consumer Survey. By the end of August 2014, all three states had finished collecting their data and shared it with HSRI for interpretation. The pilot states contracted with two vendors to conduct the in-person surveys – Vital Research and the Delmarva Foundation. During the pilot phase of the project, states' samples included older adults and individuals with physical disabilities accessing Medicaid waivers, Medicaid state plans, and/or state-funded programs, as well as older adults served by Older Americans Act programs.

Next Steps and Project Rollout

In December 2015, the project team reviewed the data and feedback they received from the interviewers in the pilot states and used this information to revise the NCI-AD Consumer Survey. This revision is based on analysis of the pilot data, interviewer comments, direct interviewer, and vendor feedback as well as expert and stakeholder feedback.

Currently, the project team is conducting a small sample in-home testing of the survey working with the Georgia Division of Aging Services and the Delmarva Foundation. The in-home testing of the survey will include cognitive testing and an inter-rater reliability study. Validity testing and internal consistency testing will also be addressed. The survey will be finalized after the in-home testing. Several states have requested that a Spanish translation of the Consumer Survey be made available. Once the final revision of the survey has been tested and is ready for use in the field, HSRI will translate the Consumer Survey into Spanish and complete a small-sample testing of the translated survey.

When both the English and Spanish versions of the Consumer Survey are finalized, HSRI will create the online data entry system application (ODESA), which will allow interviewers to collect survey data using a computer/tablet based format. NASUAD and HSRI, in conjunction with the Muskie School of University of Southern Maine and the Delmarva Foundation, will work to develop standardized materials for the in-person interviewer trainings. These materials will cover general interviewing techniques, population-specific interviewing techniques, as well as survey-specific interviewing methodology.

The Survey is slated to be finalized in March 2015, and the interviewer trainings will begin in May 2015. Data collection for the first year of the survey will begin June 1, 2015. Planning for implementation begins in the year prior to actual

survey administration because it was found during the pilot that states would like more time to work with NASUAD and HSRI in preparation for the launch of the survey. States interested in joining NCI-AD have been participating in NASUAD's monthly planning and technical assistance calls that began in June 2014. NASUAD anticipates at least 12-15 states will join the project in Year 1.

In Year 1 of the NCI-AD rollout, there will be two rounds of data collection. States participating in the first round of data collection will be asked to begin conducting in-person surveys on June 1, 2015 and send their final data to HSRI no later than September 30, 2015. State-by-state reports from the first round of data collection will be available no later than December 2015. States participating in the second round of data collection may also begin conducting in-person surveys on June 1, 2015 (or later if they choose) but have until May 31, 2016, to send their final data to HSRI. State-by-state results from the second round of data collection will be available no later than October 2016 and will combine data from states from rounds one and two of data collection.

Project Support

The NCI-AD project is funded and supported primarily by participating states. The project is a state-driven effort and participation is voluntary. The Administration on Community Living (ACL) is also providing funds to assist with survey development and support the recruitment process.

The Report

This report contains data from the pilot of NCI-AD Consumer Survey. The results are shown by state and by funding source within the state. However, since the goal of the pilot was not to compare the pilot states, but rather test and refine the Survey, the three states are not identified. They are simply referred to as State 1, State 2, and State 3.

For survey questions where there are high percentages of "don't know," "unclear," or "refused" responses, those percentages will be shown. For questions where the percentages are low, they will not be included in the tables or denominators. Questions where proxy respondents were allowed are denoted by **P**. Questions that are candidates for deletion in the revised Survey are noted in the footnotes.
