Here are a few talking points for the LG Tomorrow. I met with Brandon and he mentioned the LG will be there at 5 or 5:15pm. The social time will last until 5:40 when the event will begin. There is no need for him to come before 5pm because the fair will have ended at 3pm. Leeza will start the evening and then the LG will have about 5-7 mins to talk after the welcome by Leeza. After the welcome the event will go directly into the auction and the LG can leave whenever he needs to.

- In the US unpaid caregiving is equal to the revenue of Walmart ---- \$470 billion
- caregivers are declining - in 2030 ratio of 4 seniors to every 1 caregiver

The LGOA Relationship with Leeza's care connection has resulted in \$20,000 a year for caregiver education.

LGOA staff has been Intimately involved by training and educating caregiver mentors on dementia and Alzheimer's through the HUGS program (along with lexington medical center).

Caregivers are encouraged to find the importance of caring for themselves so that they may in turn be able to care for those they love.

Partnerships like the LGOA and Leeza's care connection are a very tangible way to demonstrate the importance of supporting caregivers across South Carolina.
