The regular monthly meeting of the Department of Transportation Commission was held at the Headquarters Building in Columbia, South Carolina. In compliance with the Freedom of Information Act, the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of December 14, 2000; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Commission unanimously passed a motion approving the sale of surplus right of way property - land, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion approving the request of the Department amend the 2001 STIP relative to the BCD COG System and Intermodal Connectivity program, as shown in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to advertise, select and negotiate with consulting firms to provide cultural resources services, archaeology and architectural history, on an "on call" basis, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the request of the Department to allow the CRM-East to advertise for and select firms for the purpose of providing engineering services for projects shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending an existing construction contract to include additional work, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in correcting the description of state highways previously added to the State Highway System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the action of the Department in removing sections of roads from the State Highway System, as shown in detail in the Appendix.

SECTION 9: On motion of Commissioner Hardee, seconded by Commissioner Truluck, the Commission unanimously passed a motion approving the removal of sections of roads in Richland County from the State Highway System through an agreement with the county that these roads can not be sold. Specific road sections are shown in detail in the Appendix.

SECTION 10: The Commission unanimously passed a motion adding roads to the State Highway System. This approval includes the addition of a cuff item for Road S-1853 in Orangeburg County. All roads are shown in detail in the Appendix.

SECTION 11: Chairman Martin stated that the next order of business was the election of a First Vice Chairman. Commissioner Hardee nominated Commissioner Truluck. Commissioner Stoddard moved that the nominations be closed and Commissioner Truluck was elected First Vice Chairman by acclamation.

SECTION 12: Chairman Martin then called for nominations for Second Vice Chairman. Commissioner Atkins nominated Commissioner Mack. Commissioner Stoddard moved the nominations be closed and Commissioner Mack was elected Second Vice Chairman by acclamation.

SECTION 13: On motion of Commissioner Hardee, seconded by Commissioner Mack, the Commission unanimously passed a motion naming a portion of Urquhart Drive in Aiken County from Sandbar Ferry Road to the SCE&G plant entrance as the "Keith Mullis Drive". A copy of the resolution is shown in detail in the Appendix.

SECTION 14: On motion of Commissioner Truluck, seconded by Commissioner Atkins, the Commission unanimously passed a motion to postpone discussion on the agenda item pertaining to the Match Program Proposal.

SECTION 15: On motion of Commissioner Mack, seconded by Commissioner Hardee, the Commission passed a motion to go into Executive Session for the purpose of discussing legal matters. Commissioner Atkins voted no to this motion.

1. **File 22.370 / US Route 17 Bypass / Georgetown County**

During construction of improvements on US Route 17 Bypass, under File 22.370 in Georgetown County, near the Town of Murrells Inlet, the Department acquired right of way by Condemnation Notice from James Alton Easson Estate dated March 10, 1964.

A request was received from Murrells Inlet 2007, Inc. a non profit neighborhood association, to acquire a small parcel of US Route 17 Bypass right of way for the purpose of landscaping and improving the appearance of a major intersection. The request was circulated to the Engineering Sections. The Engineering Departments determined that the parcel was not needed for the highway use at this time and could be relinquished provided the property can revert back to the Department for any reason deemed necessary. Therefore a Gratis Quitclaim Deed approximately 0.04 of an acre was executed on November 27, 2000.

2. **File 21.415 / Road S-31 / Florence County**

During construction of improvements on Road S-31, under File 21.415 in Florence County, near the City of Florence, the Department acquired right of way by dedication from the City of Florence dated April 6, 1954.

A request was received from an adjacent property owner to the District 5 Engineering Administrator for the Department to reduce a small portion (approximately 265 feet) of the right of way on Road S-31 and Road S-331 to remove a building encroachment which was discovered by the owner's surveyor. The request was circulated to the Engineering Sections to determine if said parcel could be declared surplus. After review it was determined that the parcel was surplus to the Departments needs. Therefore, a Gratis Quitclaim Deed for approximately 0.006 of an acre of land to Askins Real Estate, Corporation was executed December 7, 2000.

3. **File 40.468 / US Route 176 / Richland County**

During construction of improvements on US Route 176, under File 40.468A in Richland County, near the City of Columbia, the Department acquired right of way by Title to Real Estate from J. Rodney Hall dated September 14, 2000.

During negotiations for new right of way on the above project the Department acquired a parcel of land which left this remainder outside of the right of way. It was agreed that the Department would deed a small parcel back to the Grantee as settlement for a sign location in addition to a reasonable payment to settle a difficult acquisition case. Therefore, a Gratis Quitclaim Deed for approximately 0.14 of an acre of land to J. Rodney Hall was executed December 15, 2000.

This addition was sent to the BCD COG for the required thirty-day public comment period. This period ended on December 20, 2000. No comments were received.

### **REQUEST FOR CONSULTANTS TO PERFORM "ON-CALL" ARCHAEOLOGY**

To expedite project development during the 27-in-7 effort, the Department requests Commission approval to advertise, select and negotiate with consulting firms to provide cultural resources services (archaeology and architectural history) on an "on-call" basis. The Department's cost versus the consultant's cost will be evaluated on the scope of services. The evaluation is a consideration to determine the cost effectiveness of using a consultant. The evaluation will also be used when negotiating for the services of one of the "on-call" consulting firms. The scope of services will be specified on a project by project basis.

The "on-call" agreement will cover an approximate three (3) year period renewable annually beginning with the date of execution. The services will be used for both State and Federal Projects. The total estimated costs for the approximate three years of the contract is \$2,000,000.

**REQUEST FOR ADVERTISEMENT AND SELECTION  
OF FINAL DESIGN CONSULTANTS**

The Department requests Commission approval to allow CRM-East to advertise for and select consulting firms for the purpose of providing engineering services for the following projects:

- The widening of a 16.27 miles segment of US 378 in Clarendon, Williamsburg and Florence counties from Turbeville to east of Lake City, and
- The widening of a 12.5 miles segment of US 521 in Williamsburg and Clarendon counties from east of SC261 near Manning to Greeleyville.

These projects are funded with federal aid highway funds. The procedure and advertisement for selection of these Final Design Consultants is consistent with established Department consultant qualification based selection procedures.

**EXTENSION OF CONSTRUCTION CONTRACTS**

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work, as follows:

**WHEREAS**, Keith Mullis, of Aiken, served his community with distinction as plant manager for the South Carolina Electric and Gas Company's Urquhart Electric Generating Station;

**AND WHEREAS**, Mr. Mullis was a dedicated SCE&G employee for over 27 years, and a leader who was well respected by his fellow employees and the citizens of the community in which he lived;

**AND WHEREAS**, he was involved in helping his community in many ways. He was a member of the board of the North Augusta Chamber of Commerce, and was in charge of the River Scramble Golf Tournament, the Chamber's most successful fundraiser. He also was a member of the Aiken Chamber of Commerce;

**AND WHEREAS**, he was a native of Augusta, son of Gilbert Rodgers and Jeanette Pitts Mullis, and was a 1973 graduate of North Augusta High School. He earned his diploma in power technologies from ICS correspondence college in 1984, and also attended occupational courses at the University of South Carolina and Georgia Tech;

**AND WHEREAS**, he was married to the former Susan Taylor, and was father of a son and three daughters;

**AND WHEREAS**, Mr. Mullis was killed in an untimely motorcycle accident on Dec. 8, 2000, in Hilton Head;

**NOW, THEREFORE, BE IT RESOLVED** by the South Carolina Department of Transportation Commission, in meeting duly assembled this 18th day of January, 2001, that the portion of Urquhart Drive from Sandbar Ferry Road to the plant entrance be renamed Keith Mullis Drive in his memory.

**AND WHEREAS**, Mr. Gibbons has used his own equipment and has been doing so for as long as anyone can remember.

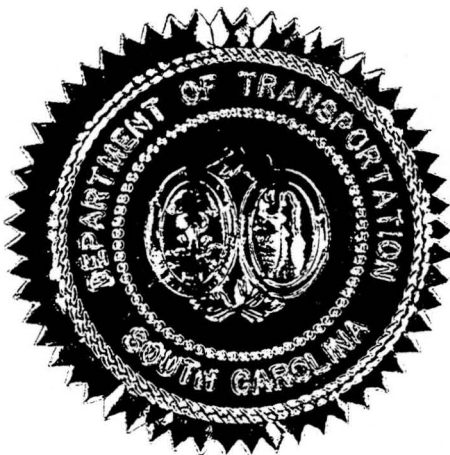
**AND WHEREAS**, he has never asked for any type of recognition and has never received any pay or compensation for his public service.
