Re: Rejected Myobloc Claims**Dear Ms. Forkner:**

We know that you are very busy so please know this letter is written out of complete desperation. We have contacted and worked with several people trying to get this situation resolved but have been unsuccessful in doing so. We are just out of options.

Enclosed please find copies of claims and letters which have been sent to Debbie Anderson in Hospital Services and Kia Anderson in Hospital Services. These claims have been filed many times every time with something new to be done. As you can see by the correspondence that I have been working on this problem since July 07. I was told on March 7, '08 during a conference call with Kia Anderson, Debbie Anderson, Robert Johnson and Christopher Lykes that they had the new claims (which had been sent to Debbie on 2/15/08 for about the 3rd time) with all the corrections and they had been sent to processing for payment and everything was fine. Then on 4/7/2008 I spoke with Christopher Lykes who told me the claims were in process and that it took time for them to be processed. Today I receive a SCMCD EOB & ECF's stating the claims have all been denied again for other reasons which should have been handled already.

These claims total more than \$16,000.00 and some are quite old. The Myobloc vials are very expensive and our office has to pay for them within three months of the injections. Our office went through the approval process with Donna Thompson in hospital services, received our approval letters and sent them with the claims in good faith that we would be reimbursed as we had been in the past. We need these reimbursements to pay our supplier. When Donna left hospital services seems to be when the difficulties began.

The patients and their ID#'s and the dates of service are all listed on the enclosed letters and claims so I have not listed them again in this letter. I have also put the enclosed documents in date order so that it will be easier to follow. We would greatly appreciate your help in getting these claims processed for payment as no one else seems to be able to get this done.

Should you require additional information please let me know. I would be more than willing to come to Columbia to meet with some one to get this resolved.

Thank you in advance for taking the time to help with this very frustrating and costly problem. Your help is greatly appreciated.

Dear Ms. Baxley:

Thank you for your letter of April 14, 2008, requesting assistance with claims payments for patients receiving Myobloc injections in your office. I understand that you participated in a conference call with Ms. Zenovia Vaughn and staff from the Division of Hospital Services on Wednesday, April 16. During the call Ms. Vaughn was able to provide you with payment dates for all but one of your outstanding claims. Mr. Christopher Lykes later contacted you with the information necessary for processing and payment of that claim.

The factors surrounding the processing of these claims involved issues other than the required prior authorization request. However, we continue to offer one-on-one trainings to providers in order to give a complete overview of program requirements and time-lines for claims submission and payments. During the call you indicated to staff that this would be beneficial and that we would hear back from you regarding scheduling.

I understand your frustration and hope that the training we provide will prevent future delays in payment. We value your participation in the Medicaid program and hope that this incident will not discourage your continued service to our beneficiaries.
