As I mentioned the document from RFA says 24.49% are from out of state drivers. That nugget is not in the Fiscal Impact Statements. As for the \$1000 per year care repair claim, its not clear where that is coming from Endra from Finance sent me the TRIP research numbers and they have an estimate in the major urban centers for the annual average addition cost to drivers for driving on deficient roads. The lowest of those numbers is Florence at \$1283 annually.
