A new wave of names are shocking the nation as the **Roman Catholic [ false ] Church** reveals which of its **priests** are **credibly accused of pedophilia**.

The massive Midwest Jesuit province is the latest region to add to a growing list of identified potentially **predatory spiritual leaders**. Jesuit officials apologized for their lack of action in a statement Monday, which was followed by a **link to the 65 names dating back to 1950**.

Names were split into three sections. The first, **priests** who were alive while the [ **Roman catholic false** ] church investigated a claim of abuse of a minor or multiple claims made after their death. The second category names deceased Jesuits who faced a single assault allegation, and the final category names clergymen cited in legal, civil or financial court proceedings.

The Chicago-based province of the Society of Jesus [ **sic** ] encompasses 11 states, and spans from Wyoming as far east into Ohio and Kentucky.

Its comprehensive account isn't exclusive to those leading in [ **Roman Catholic false** ] churches, it also includes individuals placed within **Jesuit institutions**. Those organizations include **190 colleges and 380 grade schools around the U.S.**

The president of the all boys Saint Xavier High School in Cincinnati, Ohio - Tim Reilly - believes the list will benefit the survivors of sexual abuse.

"The list will allow people to see...you know if there was somebody out there who was abused,

they'd say 'yep, I guess they know about this guy, it's not on my shoulders anymore' - I think there's also that burden if you were abused, 'was someone else also abused because I didn't say anything?' You know, they shouldn't feel responsible for that, so I think it'll give some peace to people who were abused," Reilly explained.

The announcement follows **other recent Jesuit provinces coming out with their own lists** in an apparent effort toward public transparency.

The Midwest province said it will continue updating its list on an as needed basis. Meanwhile, Jesuit officials said they've hired a third party group to investigate any new child sexual assault claims brought to their attention

This list is comprised of the names of Jesuits against whom there is one or more established allegations of sexual abuse of a minor. These Jesuits are or were members of the USA Midwest Province of the Society of Jesus [ sic ], or its predecessor entities, since 1955. This list also contains the names of Jesuits from other Jesuit provinces, who were in the Midwest Province at the time of the allegation.

The Midwest Province was formed in June 2017 from the former Chicago, Chicago-Detroit, Detroit, and Wisconsin provinces, and encompasses Illinois, Indiana, Iowa, Kentucky, Michigan, Minnesota, Nebraska, North Dakota, Ohio, South Dakota, Wisconsin and Wyoming. The Midwest Province currently has 510 Jesuit members; approximately 4,000 Jesuits have served in the province since 1955.



"For decades [Roman] Catholic officials knew of the [sexual] abuse but often preferred to reassign [ Roman Catholic ] clergy to posts in other jurisdictions, protecting the [Roman Catholic false] church WHILE PUTTING ADDITIONAL CHILDREN IN HARM'S WAY." [emphasis added]

"As early as 2002, the [Roman Catholic Charleston, SC] diocese had received allegations against 24 [Roman Catholic] priests since the 1960s, 12 of whom were removed from the ministry [sic]."

"The [Roman Catholic] Diocese of Charleston [all of SC] and many others throughout the U.S. have long refused to release a list of [Roman Catholic] priests and other employees they knew to have sexually abused minors."

"The local [Roman Catholic] diocese said it is currently reviewing its personnel files from 2007 through today. As part of its 2007 class-action settlement, the [Roman Catholic] diocese conducted an internal review of abuse allegations and shared results, including a list of names, with law enforcement. Once the current review is finished, officials will make public the complete list of abusive [Roman Catholic] priests."

"In 2007, the [Roman Catholic] diocese agreed to pay up to \$12 million to nearly 150 people - victims born before Aug. 30, 1980, who were sexually abused by [Roman Catholic] priests and [Roman Catholic] diocese employees, and victims' eligible family members. Those payouts ranged from \$13,000 to \$425,000 each."

David Clohessy, former national director of the Survivors Network of those Abused by Priests, now director of SNAP in St. Louis, has been following developments in Charleston for many years. He welcomed the news, but noted that much more transparency was needed.

"It's a very belated, grudging step that many church officials are taking these days because of tremendous pressure from prosecutors and parishioners," he said. "Kids are safer every time even a single predator is identified."

But Clohessy said the [Roman Catholic] diocese should do more than release the names of offending priests.

"We believe (the list) should include nuns, brothers, seminarians, bishops and lay (people)," he said. "We hope it includes photos and current or last-known whereabouts. If the goal is to protect kids, that information is crucial."

What's more, he called on the [Roman Catholic] diocese to share the date each allegation of abuse against [Roman] Catholic officials was deemed credible.

"That way we'll know how many years or decades [Roman Catholic] church officials have hidden these predators, " he said.

"Also on Friday, the Jesuits U.S. Central and Southern Province released a list of names of Jesuits with credible allegations of sexual abuse of a minor, ... [two of whom had had assignments in SC, including one Jesuit priest at two Roman Catholic "churches" [sic] in Greenville; and the other Jesuit priest at a Roman Catholic "church" [sic] in Charleston and at Roman Catholic Cardinal Newman High School in Columbia] ."

CHARLESTON, SC - The [ Roman Catholic ] Diocese of Charleston, the governing body of all of South Carolina's

[ Roman ] Catholic churches [sic], will release the names of all [ Roman Catholic ] priests credibly accused of sexual abuse of minors since 1950.

As part of a 2007 settlement, the [ Roman Catholic ] Diocese undertook an extensive review of [ Roman Catholic ] priest personnel and other relevant files, the [ Roman Catholic false ] church's statement said. That review was shared with law enforcement. Currently, the [ Roman Catholic ] diocese is reviewing [ Roman Catholic ] priest personnel files from 2007 through the present and, once completed, the entire list of names of those [ Roman Catholic ] priest found to have abused children will be released.

The Charleston [ Roman Catholic ] diocese settled for \$12 million the 2007 civil suit that accused [ Roman Catholic ] priests and employees of the South Carolina [ Roman ] Catholic church of sexually abusing children, The State reported. Before the settlement, the [ Roman Catholic false ] church had already paid out \$2 million to victims of abuse.

Speaking with the Post and Courier, David Clohessy, director of the St. Louis Survivors Network of those Abused by Priests, said the [ Roman Catholic ] Diocese of Charleston's set release of name's is belated and a grudging step.
