INFORMAL MEETING
April 13, 1977 - 7:00 p.m.

Mr. Poore called the meeting to order and Mr. Hooper gave the invocation.

Council approved the minutes of April 5, 1977 Council meeting as mailed.

On the motion of Mr. Hooper, seconded by Mr. Gerrard, Council voted unanimously to award the bid for three (3) four door patrol cars to Guy Motors for \$16,350.02.

On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to authorize Supervisor Edward Poore to execute an agreement with Smith Data Processing to prepare Anderson County's 1977 tax bills with the understanding that after July 1, 1977 Council would look into the matter further.

Residents of the Lebanon Community presented petitions requesting Council to rescind a Permit issued to Edward Allgood to hold a race in Anderson County on the July 4, 1977 weekend. Council accepted the petitions as information and referred the matter to the County Attorney.

Mrs. Barry Tinsley, along with other residents of Sherwood Forest Subdivision, expressed her concern that an automotive repair shop has been constructed near Anderson City Park on Lake Hartwell. Mrs. Tinsley requested Council consider adopting a Zoning Ordinance which would correct such situations in the future. Council accepted the request as information.

Mr. Ray Cox discussed the EMS Commission's budget request for the 1977-78 fiscal year. He also suggested Council consider purchasing four (4) ambulances with County funds instead of using Federal funds to help defray the cost of five (5) ambulances. If the EMS Commission utilizes the Federal funds, they would have to purchase ambulances which are currently available on a General Services Administration contract. Mr. Cox stated that the EMS Commission does not believe that these ambulances are the most acceptables for use in Anderson County. Council accepted both EMS Commission's budget request and suggestion as information.

Mr. Bill Prevost discussed the Civil Air Patrol's budget request for the 1977-78 fiscal year. Council accepted Civil Air Patrol's budget request as information.

Mrs. Betty Smith discussed the Treasurer's Office budget request for the 1977-78 fiscal year. Council accepted the Treasurer's Office's budget request as information.

Mr. Kirk Oglesby discussed Anderson Memorial Hospital's budget request for the 1977-78 fiscal year. Council accepted Anderson Memorial Hospital's budget request as information.

Magistrate Jack Gerrard discussed the Anderson County Magistrate's budget request for the 1977-78 fiscal year. Council accepted all Magistrates budget requests as information.

Judge Mike Glenn, along with Dr. James Spearman, discussed Anderson Youth Association's budget request for the 1977-78 fiscal year. Council accepted Anderson Youth Association's budget request as information.

Council held a Public Hearing to consider obligating \$7,256.09 in Antirecession Fiscal Aid Assistance for the operating and maintenance of Public Buildings Supervisor's Department Item 2b.(1) On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to adopt the Amendment to Ordinance Number 2 on First Reading.

Council discussed an Ordinance which would authorize the issuance of Anderson County Pollution Control Facilities Revenue Bonds in an amount not to exceed \$5,000,000 to finance air and water pollution control for Stauffer Chemical Company. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt Ordinance Number 15 on First Reading.

The Council meeting adjourned at 8:50 p.m.
