I, Terence Lanar Rush, do hereby certify that I am now under arrest, having been arrested in Newberry County, South Carolina, and stand charged with the commission of a crime, to wit Fugitive from Justice in the State of Florida.

I do further certify that I was on the 3rd day of October, 2015, brought before Judge Halfacre of the Magistrate Court Of Newberry, Newberry County, South Carolina. The said judge did fully explain to me my rights, as required by the statutes of the State of South Carolina, made and provided. I was further advised by the said judge as to the nature of the said charges against me and as to the demand being made by the State of Florida for my surrender to its jurisdiction and as to my rights regarding the issuance and service of a Warrant of Extradition and as to my rights to retain an attorney to assist me in my legal defense pertaining to legal proceedings.

Therefore, with full knowledge of my rights, I do hereby waive the issuance and service of a Warrant of Extradition, and do hereby waive all other procedures incidental to extradition proceedings, and do hereby voluntarily consent to return to the State of Florida and submit myself here and now to the custody of such legal authority as may be, or may have been designated to transfer and transport me from Newberry County, South Carolina, to the jurisdiction of the State of Florida to face the said charges against me in that jurisdiction. I hereby release any and all members of the Newberry County Sheriff's Department from any liability relating to my arrest and custody in connection with the aforesaid charges(s).


