To Who It May Concern;

On August 28, 2015 my daughter Misty Friend (Glenn) and her on again off again boyfriend Jason Daniel was arrested for

Drugs/Trafficking in Heroin

Weapons/Poss. during violent crime

Weapons/unlawful carrying of pistol

Drugs/Possession of other controlled sub.

Unlawful Neglect of Child

My granddaughter Aubree was with Misty and Jason when they got arrested and was placed in CPS. My grandson Kayden was at school and was placed with Jason's Uncle Gary. This was due to Misty telling the Officers not to let me have her children.

Misty had lived with me for 1 & 1/2 years this time before see met Jason and moved in with him at his grandmother's house the end of January. From March til now she has left Jason 3 different times.

We have been to Family Court 3 different times with no solution. Misty (which has not made good choices lately) wants the Children to be placed in a home that has multiple problems.

Misty made a Police Report stating that one of the children in this home had molested my grandson Kayden. (why would you put your children in more Danger)

One of the Children in this home has allot of mental problems and the other has extreme physical problems

There have been Drug Activity going on at this home. (one of the homes where Misty and Jason bought drugs)

At the first Hearing I was the only one that came forth asking to take Temporary Custody. The Judge ordered a Home Study to be done and stated that if I passed both children were to be placed with me. The DSS Case Worker did the Home Study and told me on two different occasions that I Passed. The Case Worker apologized at the Home Study saying that she had been thrown into this case and didn't know what she was doing. This became evident when she called me on September 24th not realizing she needed 3 references from me. I got 3 more phone calls from her on the 25th because she had lost my paper work for the case.

On the September 28th Court Hearing we sat in the hall waiting for hours before we were told by the Bailiff that Misty's Attorney couldn't make it. When I walked outside to leave I stopped and talked to the Case Worker. She told me she could not tell me anything about the case because Misty didn't want me to know and that I would be subpoenaed for the next Court Date. I never received a subpoena but was notified by my Attorney that the next Court Date was October 12th.

The following statements were made at the October 12th Hearing that were Not True.

\* That I had Alienated myself from my daughter and grand babies

\*That I did not pass the home study ( I was already told twice that I did)

\*That I was wanting Full Custody

DSS stated that they felt that my grand babies should be placed in this other home. My Attorney told the Court that there were circumstances that the Court and the Guardian was not aware of and told the Court of the Molestation Report. Jennifer (from the other home shouted out and was removed from the Court. She had also showed out at the first hearing in September). The Judge Ordered a continuance because DSS stated that Misty and Jason (which is not the father of the 2 children) had not been properly served. While still in the Court Room after Court, I told my daughter that I Loved Her. She shouted at me and Officers surrounded her. I was ask to stay in the Court Room until she left and then an Officer walked my out. I'm assuming because of all the commotion. The next Court date was not set before we left.

I called multiple times to try and find out when the next Court Date was to no avail. On October 28th I received a call from my Attorney to be in Court at 2:00 p.m. I rushed to get there only to be told that once again Court was postponed. I'm told we have another Court Date for November 9.

I'm letting my Family's Story be known in Hopes that other Familys will not have to go through this nightmare. I Love My Daughter and Grand Babies with everything that's inside me and will do whatever it takes to Protect Them. My Daughter did pass a hair drug test (which in research I've found it's easy to do). I know that she is affected by the money that was made selling the drugs. I'm asking for help to Save her and my Grand Babies from this Life.

Please contact me with advise on doing so.
