### Governor Nikki Haley News:

Four years ago, first-term Gov. Nikki Haley endorsed Mitt Romney in the 2012 Republican primary. Her endorsement was viewed as a coup for Romney. The former Massachusetts governor could pick up Tea Party support with Haley aboard, analysts predicted.

**Note:** “People don’t understand,” she said when I asked her about Washington and, specifically, the possibility of being part of the next ticket. “Look at this year. When have I had time to think about it? So it’s the furthest thing that I’ve thought about. I appreciate that my name comes up. But there are a few things people need to think about. There are 16 (sic) candidates, which means there are 15 very good candidates (for vice president). Secondly, I have a daughter that’s a senior in high school and a son that’s in eighth grade. I’m at that point where I’ve really got to focus on my family.”

**Note:** And yet ... “Should someone ask to sit down with me, of course I would sit down with them. But there’s a lot of other factors at play. And I’ve still got things I want to finish in South Carolina.”

**Post and Courier:** S.C. farmers plead for immediate flood assistance

Hundreds of farmers traveled to the Statehouse on Monday to ask Gov. Nikki Haley to request immediate federal assistance to stave off bankruptcies and foreclosures after historic rains and flooding in October wiped out crops. S.C. Farm Bureau President Harry Ott said before a news conference that farmers can’t relocate and reopen like flooded-out small businesses.

**Note:** Haley has made a request for expedited crop insurance claims to the U.S. Department of Agriculture, but the governor’s spokeswoman, Chaney Adams, said Monday that Haley does not intend to ask for supplemental funding for farmers.

**Note:** “What the Farm Bureau has asked for is direct cash payments from the federal government to farmers who chose to be under-insured, something that no other industry in the state is asking for or will be receiving, and the governor does not believe we should treat farmers differently than any other business owners in South Carolina,” Adams said.

Farmers packed the Statehouse on Monday to beg Gov. Nikki Haley to ask Congress for money to offset their estimated \$376 million in losses from last month's historic flooding. But the Republican governor is unwavering in her refusal. Farmers should have federally subsidized crop insurance, and under-insured farmers shouldn't be bailed out, her office said.

**Note:** "The governor does not believe we should treat farmers differently than any other business owner in South Carolina," said her spokeswoman Chaney Adams.

**The State:** Improving 32 flood-damaged bridges would cost \$55 million

Major repairs to 32 structurally deficient bridges damaged in October's flooding would cost \$55 million, the state's interim roads chief said Monday. That cost would be in addition to the \$137 million in federal and state money to repair road damage from the flooding. The state Transportation Department is asking for \$49

million from the state for those repairs.

**Note:** Gov. Nikki Haley must ask the federal government for money to offset losses not covered by crop insurance, Weathers said. But Haley has not requested the money, he said.

**Note:** But Haley's office said the affected farmers had access to federally subsidized crop insurance and lost revenue insurance.

South Carolina's number one industry, agribusiness, is still in desperate need following the October Flood. With a loss at \$376 million and counting, the Department of Agriculture and SC Farm Bureau Federation asked a special Senate Committee for support in asking the Governor to request federal assistance.

**In a statement to News 19, Haley's press secretary, Chaney Adams said:** "Agriculture is the number one industry in South Carolina, and there has never been a time since taking office when Governor Haley did not stand with our farmers - and she stands with them today. The historic flood that hit South Carolina in October damaged businesses and homes across our state, and farmers were not spared. ..."

If you paid attention to the national media, you would think our Thanksgiving holiday weekend was more about shopping than for sharing meals and spending time with family and friends.

Consider the post-Thanksgiving holiday itinerary: There was Black Friday, which, for some retailers, began Thanksgiving. Then, there was Small Business Saturday.
