CMS Issues State Innovation Models Request for Information

In case you missed it (ICYMI): CMS released [a request for information \(RFI\)](#) to solicit stakeholder feedback on state-based payment and delivery system reforms to help shape future federal-state initiatives. Since 2013 through the State Innovation Model (SIM) initiative, CMS has supported states in exploring payment and delivery reforms. HHS is now seeking input on how to evolve such efforts that both leverage lessons learned and consider how to implement models under the Medicare Access and Reauthorization Act (MACRA). We encourage state officials to seize this opportunity and share feedback by the October 28, 2016 deadline.

Upcoming CMS Webinar: Linking & Merging Data Sources

In 2014, CMS launched a collaborative between the Center for Medicaid and CHIP Services (CMCS) and the Center for Medicare & Medicaid Innovation (CMMI) called the Medicaid Innovation Accelerator Program (IAP). The goal of IAP is to improve the care and health for Medicaid beneficiaries and reduce costs by supporting states' ongoing payment and service delivery reforms through targeted technical support.

As part of their efforts to roll out what they and their partner states have learned from the first year of the Reducing Substance Use Disorders program area, CMS invites you to join their next national dissemination webinar on **Wednesday, September 28, 2016** from 3:30 - 5:00 PM EDT. In this webinar, entitled "[Linking & Merging Data Sources](#) ", participants will discuss merging Substance Use Disorder (SUD) related data sources with other state databases. Specifically, the discussion will focus on how using different data sources can provide additional insight on a patient's continuum of care when services are paid for by Medicaid and other state agencies. There will be three featured state partners on the webinar panel to discuss their efforts to actively link or merge data and field your questions. On this webinar:

- Connecticut will discuss how it is using distributed data networks to answer questions about their SUD population demographics, care outcomes and costs;

- Washington will discuss how it has designed meaningful measurement concepts that enable policy analyses, program evaluations, predictive modeling and performance management; and
- Oregon will share how it developed a system to combine SUD block grant data with Medicaid claims data to analyze treatment outcomes and share information with providers.
