Lily,

The following event was discussed in our group meeting at the State House a few weeks back, but I wanted to provide some additional information in case the Lieutenant Governor's schedule would allow him to participate.

June 21 is the longest day of the year, and it's also the Alzheimer's Association event that is symbolic of Alzheimer's Disease... being both lengthy for the care giver and the care recipient. Similar to last year, the Alzheimer's Association will host a walk around the State House from 8:00a until 5:00p (this long time period also goes along with the longest day theme). It's a relatively simple set-up outside... they will have a tent /table near the entrance with materials, stickers, and water for participants.

Last year, we held a brief press conference out in front of the State House (at 10:00a or 10:30a) to address the purpose of the walk with media in attendance. As this is a fixed day for the Alzheimer's Association, connected groups have already been invited. We also have a sign-up sheet posted in our office for employees.

If and when you have a chance, please let me know if the Lieutenant Governor would be able to participate in any capacity (press conference or walking) or if you need any additional information.
