Today, at about 1p.m., I stopped at the McDonalds located on Hwy. 321 at the intersection of I-26. As I entered the parking lot, I noticed only the handicapped parking spaces were vacant next to the building. Consequently, I parked across the drive and parked where there were many open spaces. As I exited my truck, a gray Dodge Caravan pulled into the first handicapped parking space. On the rear window was a State of South Carolina sticker and a state license tag with the numbers SG 88137 on it. The female driver began talking on the phone. I went into the rest room and washed my hands. When I came out she was still on the phone. I went to my truck and wrote the above identification down as the driver exited the van. She went in and make her purchase then returned to the van, cranked up and drove off. The driver was not in any way handicapped based on my observation. There was nothing to identify that a handicapped person was driving the auto. There were no passengers.

I guess my question is: When did state laws not include state employees?

I apologize for the delay in responding to your request regarding the above referenced vehicle. The vehicle is leased to the Lexington County Recreation and Aging Commission (LCRAC) under the Medicaid Transportation Program. The LCRAC reported to our Agency that after an investigation of the incident, the driver of this vehicle has been reprimanded for her actions.

It was also stated in their response that the driver is a long-time employee of LCRAC and is fully aware of the states rules and regulations with regard to driving a state vehicle. However, in her explanation of the incident, she stated she had received a call from her child who was in school that day and was unaware that she had pulled into a handicapped parking space.
