Statement - Audrey Wilson

I met Sanford Dean Harsely at work where I had been working for 4<sup>+</sup> years as Assistant Director of Nursing and he worked for Regional Ambulance Service as a driver. He had asked one of my co-workers to ask me if it was alright to call me to ask me out. I was happy with my life, going to church every Sunday morning, Sunday night and Wed. night and I was taking Vacation Bible School and working toward teaching a Sunday School class. I was also VERY happy with my job and planned on retiring there. I loved my patients and my coworkers + they loved me. I even took patients out on day trips (fishing, state fair) for those that didn't have family to take them. One of my residents was transferred to another facility and called me on my personal phone every day begging me to let him come back to my facility until he eventually died in that facility. I said all that to say that how much I loved my residents and my job and they loved me.

Not long after SDH (Dean Hershey) got permission to call me, he asked me out on a date. I was reluctant to go out because I was FINALLY happy with my life. My son, daughter in law, and granddaughter was living with me and I didn't care to change any of that. Well, I gave in and went out to dinner with him. We started spending more + more time together, going fishing, going on weekend trips, and even went on a cruise. However he had made the comment to my mother that he was going to get me away from my kids and my family. He had started staying with me in my nice 2 story house in Blue Heron. Eventually, he succeeded in convincing me to move my son + his family out of a small mobile home + moved me away - about an hour away from my job out at Lake Murray in Gilbert SC. I rented the house in my name + he moved in with me. He used his money to buy boats and toys while I worked full time to pay the rent and bills. We moved in that house in Oct 2013 and he became verbally and mentally abusive towards me.

By December, it became obvious to me that we were not going to work out. We had become engaged back in Sep 2013 but by Dec. 13 after ~~we~~ moved I stopped wearing my ring and began sleeping in a separate bedroom. At times he would come into my room and try to convince me to sleep in the bed with him but I would refuse and he would force sex on me. I told him I was not happy and things had to change. After the holidays, in Jan. 2014 he lost his job for whatever he did to lose it, he was not eligible for unemployment so I was left to pay all the bills. In Jan 2014 I asked him to move out at least for a while back to his house just to give us some time apart but he refused I said he wasn't leaving. He continued to live there for another couple of months so I told him I'd give him 30 days to please move out. I asked him to please do it the nice way and please leave so that I wouldn't have to do it the mean way and have him legally evicted. The

last week of the 30 days, he came into my room + forced sex on me at least twice. I told him I would be going to the magistrate's office ~~st~~ thing Monday morning to have him legally evicted. Starting that Friday evening in March I started yardwork, taking pine straw + putting it in flower beds, picking up pine cones, etc. My neighbor (landlord) came out and was helping me - NOT DEAN! My landlord asked me why he wasn't out there helping me. I told him he just didn't do much house or yardwork. That same week I had gone to my landlord and his wife + told them he had raped me + I was going to have him evicted. I had also texted a good girlfriend of mine + confided in her that he had raped me + that I was going to erase my text but for her to keep hers for evidence (Cindy Lazarek - a co-worker + friend of mine). I had also called an old friend of mine during that same week + told him I was very unhappy + that I was in a bad situation - so people knew I was in trouble.

After doing all the yard work that week in March, I had gone outside on Sunday morning with my coffee and my radio and continued taking pine straw. He then came outside while I was working (I never went back inside the house). I had a ladder on the porch with my phone sitting on it and my satellite radio sitting on a generator that belonged to him. When he came outside he began harassing me about cheating on him (even with other women) and then slung my satellite radio off the generator because he said it was his generator + then grabbed my phone off the ladder, threw the ladder on the ground + took my phone + ran off with it threatening to throw it in the lake. I then began to walk towards my neighbor's house to call 911 to have him removed from the property. He then threw the phone back at me + I then called 911. I told the operator what had happened - no physical contact had occurred, just verbal + mental harassment + I was afraid of him + that he had raped me.

She (the 911 operator) asked if I wanted to stay on the phone with her until the officers arrived + I said yes - she stated to me that she could hear him follow me around in the yard + laughing at me saying I was going to jail. I had told him very calmly before I called the police to please go take a ride in his boat and calm down + get his mind off of things while I was doing what I enjoyed which was yard work, but he refused + set up a scene in the house which he told police that I came inside the house and beat him up while he was in the shower - he cut his lip with his razor + from what I understood from my lawyer, he had blood in the shower + was walking around with a napkin on his lip + told the police I had hit him. Since I am a nurse, I had a couple of insulin syringes in my pocket from work + he told the police I was stealing drugs from the nursing home + "shooting them up." This was reported to my job + the nursing board did an investigation at the nursing

None + not ONE pill or liquid or ANY drugs were missing the entire 5 years I worked there!

The cops eventually arrested me because he lied about me hitting him. I had bruises on my body from the rapes but they never examined me even though I told them he had raped me. Neither did they drug test me for the allegations he made against me. Rather, the jail tried to give me lithium they said to "detox" me when I didn't need detoxing. My doctor has been treating me for Multiple Sclerosis symptoms for 3 years in which I went to the dr to see him EVERY MONTH that entire time. I had MRI's, spinal taps, seeing a neurologist, and a urologist, so I was on prescription drugs from my doctor which the jail never tested me for either. Since I was reported to the Nursing Board, I had to go through their assessment at LRADAC which I passed and was released from their service.



Due to all of this injustice, I lost everything I worked for as a nurse for 25 years - my house, my car, my retirement, most of my furniture and most importantly, my nursing license has been suspended so now I can't get a job to support myself, live a permanent residence, and I can't get a car to even look for a job or anything. Also at this time, my rent is past due & my utilities are past due & about to be cut off - and I can't give my grandkids Christmas this year! Meanwhile, he has never been punished in any way and he has now moved on with his life with a new job, boat, etc - working for St. ~~And~~ Matthews Ambulance company in Lexington & going to school on Mon & Wed nights on Leaphart road trying to get his **EMT** certificate.

All I ask for is justice for ME - let me have the chance to get my life back, let me have my nursing license back that has been SO unfairly taken from

me! And punish him for lying and ruining my life! He should not be allowed to drive an ambulance around patients. He's dangerous and unstable.

Please help me get my nursing license back so I can start my life over again - I'm already 32 years old so it's not going to be easy. I completed the PTE program but I still have to pay the \$285 to have my record cleared, which I don't have!

I am going to list these important names and numbers to people + others that know what happened and can vouch for me + my character. I've tried so many people and ways to get help + no one will help me!
