We saw the published story below and wanted to clarify it, so it is correct.

1- The is not active duty S.C. Army National Guard Soldier—he was assigned here briefly and left the S.C. Army National Guard well before 2006—transferred to and worked at National Guard Bureau in Washington D.C.

2- All of the allegations and activity occurred when he was assigned to National Guard Bureau in Washington D.C. not the S.C. Army National Guard. The story is written as though he was a member of the S.C. Army National Guard during these activities, which he was not.
