> SCFRW is moving forward with plans for the 2017 Spring Board Meeting &
> Legislative Day for Tuesday, April 11, in Columbia. The SC Legislature
> voted to shorten the regular legislative session by three weeks and
> this created on-going changes in the legislative calendar as it
> relates to furloughs.
> As a result, this has made it extremely difficult for SCFRW to get
> confirmations on the SC Statehouse schedule. As a result of these
> changes, the SC House of Representatives will not be in session the
> week of April 11, and the Senate hasn't confirmed their schedule yet.
> On April 11, Peggy McMaster is hosting SCFRW at the Governor's Mansion
> and providing heavy hors d'oeuvres at 1 pm. The Governor's Mansion was
> not available the following week.
>
> Legislative Day is usually held the opposite year of the convention.
> This is done intentionally to reduce the request for competing funds.
> Unfortunately, Legislative Day and the SCFRW Convention are both in
> 2017. SCFRW has to prioritize our financial responsibilities and the
> convention takes precedence!
> The SCFRW \$20 registration fee will cover the breakfast and the
> Governor's Mansion is providing heavy hors d'oeuvres. For this reason,
> there is no need for Legislative Day sponsorships. On the other hand,
> a SCFRW Convention is expensive and requires a lot of sponsorship
> money to offset the costs. This year's convention will be held at the
> beautiful Westin Hilton Head Resort & Spa which is on the beach.
> Remember: Location, Location, Location!
> A convention in Hilton Head is going to be pricey compared to
> Spartanburg.
