The Supreme Court of Pennsylvania will create a state Office of Elder Justice to protect seniors from abuse and financial exploitation, primarily through proposed reforms to court-appointed guardianships.

The new office was recommended by a 38-member Elder Law Task Force, which released its report today after 18 months of research. The new office, which is being staffed by existing personnel, will be established in January 2015 in the Administrative Office of Pennsylvania Courts at the Pennsylvania Judicial Center in Harrisburg.
