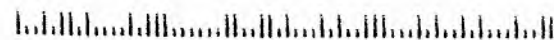

I got the same response when clicking to see my Archived Reports.

I did, however, get a response saying I had two options to PURCHASE my credit report. Is that what this so-called IDPROTECTION really is? Just a clever way to get me to buy what should be mine already? [END OF EMAIL]

I have not received a response yet, but wanted to let you know of this situation. I will advise further on their response.

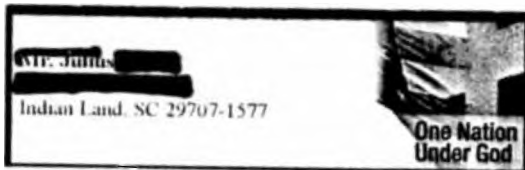

monitoring and identity theft protection.

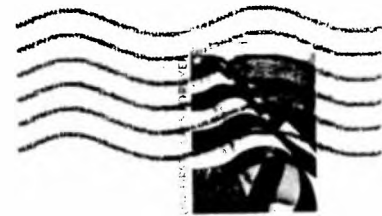

According to the Mandiant report this Tax Breach started on August 13, 2012 when one employee, "user clicked on the embedded link, unwittingly executed malware and became compromised. The malware likely stole the user's username and password." So once again the Hacker used individual's online accounts to access internal systems. Dear Governor Haley,

While I do not live in SC, I still own property and pay SC taxes so I hope your staff will not dismiss this email based on my current primary residency address. At some point I hope to return SC in re-establishing myself as one of your constituents' and/or an SC resident.

The matter of securing SSN information is not new to me. It is a subject of concern that I have tried to raise with the FBI and members of the United States Congress here in CT (namely Congresswoman DeLauro and her office) however, the attitude of "out of sight, out of mind" seems to be the approach by those who should make it a priority in addressing such concerns until it happens to them. Not a "proactive approach", Madame, but a continued "reactive" one that does not prevent such issues from occurring.

I applaud your efforts of coming forward in providing the residences of SC "proper notice" rather than waiting six or seven years when it comes to informing those whose information is at risk because by coming forward now, just a few months later, you ultimately provide the "victims" with the ability to watch out and protect themselves from being victims further – you empower them. At one point in my life, an employer I worked for gave a tape back up to a vendor for the company's stock holders meeting that contained my SSN and that tape backup was lost or stolen. It took the vendor 6 years before they notified me and for six years I was powerless to take any action in protecting myself. So when they did finally tell me, I wasn't too happy about the "delayed notification" because for six years that information was missing and I wasn't told and at risk. But today, I read of the event in SC that can impact me and I am more appreciative of your honesty than you would know otherwise, so thank you Governor Haley, for your courage and for your honesty in coming forward in several ways of making people informed because I became informed at a distance and I know so I am better prepared on what I can do to protect myself and my private information.

While the media reports you have addressed your own state concerns on behalf of all states (kudos for going above and beyond in your efforts), I once attempted to address my concerns with the Federal Government because several "agencies" publish warnings against identity theft and what an individual can do to protect themselves but no one else appears to adhere to, follow, or support such recommendations that are made by those Federal Agencies that publish such protections on their websites, especially in the Private Sector where a person's SSN (and other Private Information)

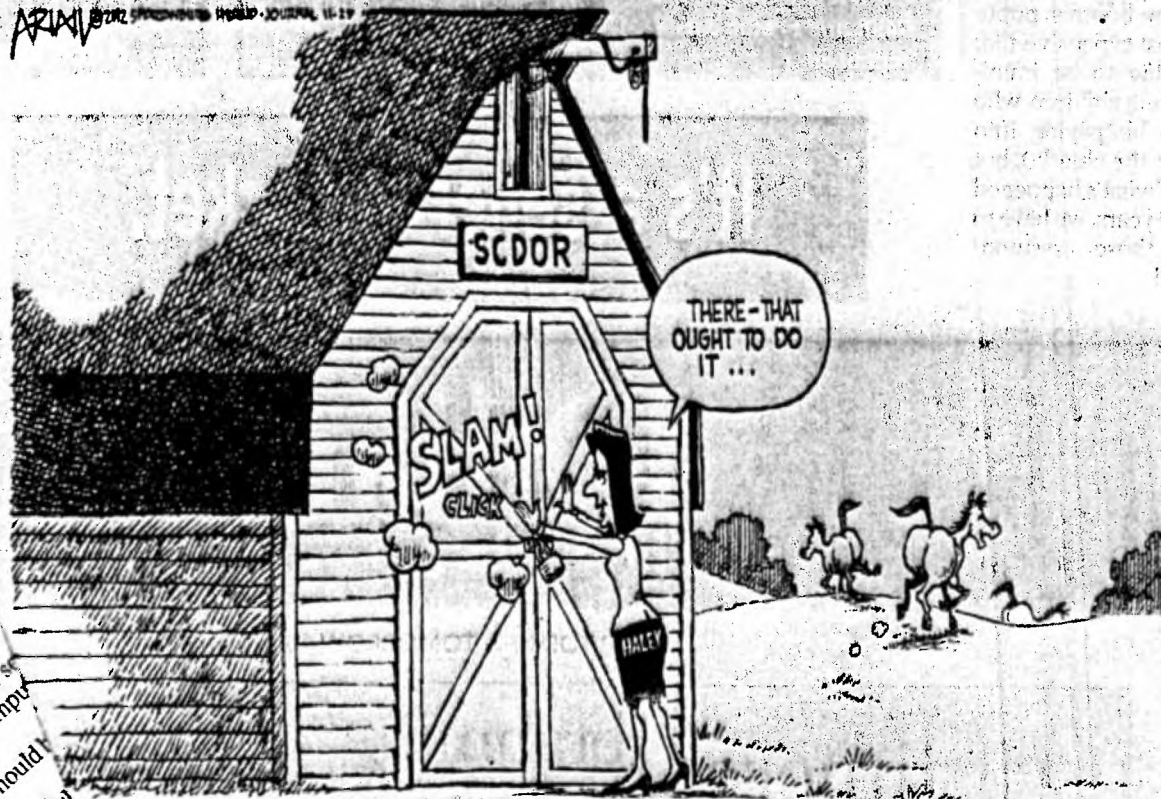

We are married and filed our taxes jointly so my social security number and other identifying personal information appears on the annual tax returns that we filed with South Carolina for 3 or 4 years; up until last year 2011.

Experian and Equifax have agreed to extend credit protection but TransUnion has declined to cover me.

Here's a copy of the notification I received yesterday:

As a resident of South Carolina I am very concerned with the recent data breach at the SC Dept of Revenue. I believe that the government agencies have taken appropriate preliminary steps to offer protection for SC taxpayers who's data has been compromised. However, I am disappointed that protective actions are limited to one year and that at the current time SC residents would individually bear the expense of extended monitoring. That said, there is at least one additional option available to concerned SC residents. All three credit bureaus offer products, free by law, for extended fraud alerts. Once one of the alerts is placed with a single bureau the information is forwarded to the other bureaus by default. Once an extended fraud alert is place, creditors must contact the consumer before opening new lines of credits. Yes, this complicates the experience for the consumer as well as potential fraudsters, but isn't that the point? The one problem with this solution is that the credit bureaus will not file an extended fraud alert without a written police report proving that your data has been stolen. I urge you to work with the credit bureaus and state law enforcement officials to develop an approach to extended protection that does not put onerous requirements on the victims of this data breach.

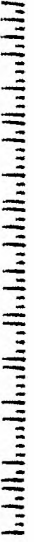
