Dear State Representative,

This e-mail is to notify you of a computer software programming error at the SC Department of Employment and Workforce (DEW) that may have impacted some of the businesses in your area. Each impacted business will be

notified within the next three business days.

This computer software programming error affects only ten percent of all the businesses in the state, and has the potential to marginally impact a business' 2013 tax rates. The majority of businesses will not receive any type of bill as a result of this error. There are 399 non-profit/governmental entities that will receive new bills related to the issue.
