Dear Governor Haley:

With a new year, new staff and new legislative session, we encourage you to lean on your oldest and most trusted partner in education, the Education Commission of the States. In most states, the governor or his/her designee is an ECS Commissioner by default.

We recommend that appointments be filled with commissioners of education or state superintendents, commissioners of higher education, legislative chairs of education and appropriations committees and other key education leaders in your state. Some states have even inserted this recommendation in statute. These individuals will not only help shape ECS' research, but also allow for a clear line of communication with your state. It is this idea of working across silos that allows ECS to have deeper and more meaningful collaboration on critical education issues.

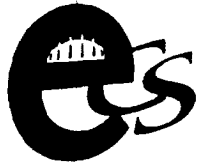
