This concerns David Stanley. He has last worked in 1994. He has had back pain since I met him in 1985 he got hurt while working as a cabinet maker and installer around 1984. When I met him he worked for Food Lion. He has never really been able to hold down a job for very long because of his back and general health problems. He has worked off and on, since I have known him. However, not in the last 10 years, he has had severe back pains, and has suffered a stroke.

On December 4, 2004 David had a stroke that thankfully left no long term effects. I believe that the stroke could have been caused by his being subscribed and using Celebrex. He was treated at a local hospital because he could not be commuted to a VA hospital, he was in the hospital for about 5 days.

He was very fortunate and I need to say that I believe in God and the power of prayer. So he was actually very blessed. In that he had no long lasting effects from the stroke. That cost us over 30,000. there is no way that I can pay this, money has been taken out of my income tax return, to try to pay this debt.

David has had different illnesses, stomach problems, irritable bowel syndrome all pretty young he was only 44 when he had his stroke. As far as his back goes he has degenerative bone disease, bulging disc disorder, nerve damage, spinal stenosis and arthritis in his back. He has been living or trying to in a severe amount of pain. In the last year he has been in constant pain. A couple of years ago the VA had him see a Spinal Surgeon Dr. Michael Wildstein, who ran some tests MRI and ex rays all of which he has had many times before. Dr. Wildstein said that David should have surgery, this was a surgery to clear away where there was some disc that needed to be scraped away. The surgery was done and helped David to some extent however, eight months later he had a more serious back surgery eight hours involving two titanium rods and five screws along with plastic and bone marrow discs. A horrible surgery, we are very thankful for the doctor and the staff at the Ralph H Johnson VA Medical Center. A weeks stay in the hospital and at least 3 months of recuperation, prognosis is good a full year to recover. There you have it, We have not been able to draw any disability or financial help of any kind. We owe thousands of dollars to local hospitals, and are trying to live on one income.
