

I am writing to let you know that Unison Health Plans, a multi-state public sector health plan enterprise, is being acquired by AmeriChoice, a UnitedHealth Group company offering government-sponsored health plans since 1989. Unison Health Plan of South Carolina, Inc. is included in the purchase. The combined entity will serve more than two million people across 20 states with no geographic overlap between AmeriChoice and Unison.

The acquisition will combine the strengths of two innovative industry leaders that have a similar heritage of providing traditionally underserved populations with access to quality health care and services through state Medicaid, State Children's Health Insurance Programs (SCHIP), Adult Basic Programs and associated Medicare Special Needs Plans. Our companies' commitment to clinical excellence and operating efficiencies will position us uniquely to better serve and extend care to the uninsured and underinsured and to become a significant part of your state's plans to cost effectively extend healthcare to additional adults and children.

Both management teams will work to leverage best practices across the combined organization and to bring to Unison additional resources from AmeriChoice and UnitedHealth Group. Unison will leverage UnitedHealth Group assets such as the data management capabilities of Ingenix. Ingenix applies technology and health intelligence solutions that help payers, physicians and hospitals to correctly document, bill, transmit and reimburse health care services, to control health care costs, to manage financial risk and to improve the quality of care. In addition, through UnitedHealth Group's OptumHealth group, Unison members will have access to a wider range of specialty health services such as dental, behavioral health, disease and case management.

Current Unison management will play a key role in the leadership of the combined businesses and in continuing to help state and local government organizations efficiently provide high quality health care to their constituents. The transaction is expected to close by mid-2008, subject to required regulatory approvals and customary closing conditions.
