That was quick. Judge Anderson granted an oral motion (over my objection) by Ms. Martel to file an Amended Complaint on or before June 20, with the defendants' Answers or Motions to Dismiss due on July 18. Plaintiff's counsel withdrew the Motion to Remand. The effect of it all is that now there is nothing pending, and we start all over in June and July.

Plaintiff's counsel also asked if she could file a motion for a TRO or preliminary injunction, and Judge Anderson advised that he would not consider such a motion until the complaint had been amended.

The effect of it all is that now there is now nothing pending, and we start all over in June and July. I suspect that my next Answer and Motion for Summary Judgment may not be all that different from the previous ones.

As far as I know, there was no press coverage, but I might not have noticed if someone slipped in at the last minute.
