This week, the House passed [H.4145](#), a bill that implements a statewide Coordinating Council for Workforce Development and incentivizes scholarships and apprenticeships to build our workforce throughout the state... This initiative is one of our [Competitiveness Agenda](#) items for the 2016 session and is scored in this year's legislative scorecard.

SC Chamber President & CEO Ted Pitts said, "The State Chamber thanks the House for its work on H.4145, which we see as a significant step toward coordinating workforce efforts in the state and closing the skills gap. We are pleased to see the momentum continue to grow for developing our workforce in South Carolina. This remains a top priority for the business community and is a key piece of the State Chamber's Competitiveness Agenda." Bills on our radar:

[S. 493](#) – Professional Employment Organization Service Agreements

This bill provides for allowing clients of Professional Employer Organizations (PEOs) to obtain job tax credits offered to small business that create job opportunities in the state. This provision would not only help PEOs in their efforts with small businesses but also

aid those small businesses who wish to expand and create South Carolina jobs.

STATUS: Chamber staff was present at the full Labor, Commerce and Industry Committee where the bill received a favorable report as amended.

H. 4435 - Advanced Manufacturing Instruction Act

Sponsors: Rep. Gilliard

Summary: This bill would require every school district, beginning with the 2016-2017 academic year, to provide elective instruction in advanced manufacturing for students in grades 6-12.

Chamber Position: Monitoring

H.3430 – Addressing Unsafe Used Tires

This legislation prohibits the sale of unsafe used tires, and defines “unsafe,” whereas currently, no regulations exist in South Carolina to help ensure that used tires are indeed safe. This is a safety issue for vehicle drivers, occupants and others on the road. In keeping with our commitment to sustaining a competitive environment for businesses to grow and prosper, while ensuring the safety of our citizens, the Chamber supports the passage of **H.3430** and is actively urging the Senate to do so with no further amendments...

H. 4457 – Magistrate Jurisdiction

Sponsors: Rep. Huggins

Summary: Increases the civil jurisdiction of magistrates from \$7,500 to \$15,000.
