Personhood amendment making inroads in Colorado

Personhood Colorado is preparing for a major effort to get a proposed pro-life amendment on an upcoming ballot.

The amendment would declare that personhood starts at "the beginning of biological development of a human being," which changes the previous amendment's wording from "the moment of fertilization."

Personhood Colorado campaign co-chairman Gualberto Garcia Jones says 75,000 petition signatures are needed to get the issue on the 2010 ballot. He is optimistic because his group did well taking the issue to voters last year.

"Not all abortion opponents agree with the "personhood" campaign. [Roman] Catholic bishops in Colorado, Montana and North Dakota, as well as the [Vatican – proxy] National Right to Life group, didn't endorsed the amendments or bills. They called the "personhood" amendments a roundabout way of challenging abortion rights and preferred a direct refutation of the Roe v. Wade decision giving abortions constitutional protection. They haven't yet said whether they'd back next year's proposed amendments.

Some abortion opponents say the "personhood" movement would more effectively ban abortions, and they don't mind the long odds for success.

"It reorients the debate and gets us to the core of the issue," said Les Riley of Pontotoc, Miss., a tractor salesman and father of 10 who is gathering signatures to put the amendment on Mississippi ballots next year.

Riley says he's halfway to getting the 90,000 signatures needed. Lt. Gov. Phil Bryant, a Republican, signed the petition in July.

Riley says the ballot effort has been a blessing, even if it fails there, too.

"The opportunities to minister to people one-on-one, it's amazing," Riley said.

The anti-abortion Amendment 62, which sought constitutional rights for individuals "at the beginning of biological development," lost Tuesday night by a 3-to-1 margin - the same as the 2008 vote on a nearly identical measure.

However, supporters of 62, known as the "Personhood Amendment," said they considered their campaign victorious because it "helped save babies' lives."

Amendment opponents said their coalition of more than 70 organizations and individuals did a great job of educating voters on the far-reaching consequences of this measure.

The "No on 62" campaign, led by **Planned Parenthood** of the Rocky Mountains, **NARAL Pro-Choice Colorado** and **New Era Colorado**, **raised about \$578,000 in cash contributions**, almost 10 times the cash that supporters received.

Personhood Colorado and other amendment backers said whatever the final result, they had raised awareness of their cause and persuaded some women to give birth rather than choose abortion.
