Directions, Transportation and Parking

From National Airport

Head north toward Aviation Cir/Ronald Reagan Washington National Airport Access Rd and continue straight onto Aviation Cir/Ronald Reagan Washington National Airport Access Rd. Take the ramp onto George Washington Memorial Pkwy. Take the exit onto I-395 N toward Washington, entering District of Columbia. Take the 12th St exit toward L'Enfant Promenade. Turn right onto E St NW and the conference center will be on the left.

From Dulles Airport

Head east on Saarinen Circle and continue onto Dulles Airport Access and Toll Rd Merge onto VA-267 E Merge onto I-66 E, entering District of Columbia. Exit onto Constitution Ave NW. Turn left onto 12th St NW. Take the 2nd right onto E St NW and the conference center will be on the left.

By Metro

The conference center is located in the historic Penn Quarter at 901 E Street N.W. It is conveniently located next to the green and yellow metro lines at Gallery Place / Chinatown metro stop and the red, orange and blue metro lines at Metro Center. Parking

The nearest public parking garage is Altman's Parking Garage located at 901 E Street, NW (off of E Street NW before 9th Street NW). Parking is \$5 per hour for the first 2 hours after which the \$19 daily parking rate applies.
