I told the IRF I didn't necessarily consider service accomplished and when I talked to Lisa she said that she called the Judge's law clerk and, according to them, we are not proper parties. Because this is a Qui Tam, the plaintiff needs the court's permission to add parties. At this point there has been no ruling on the motion by the court. This is all under seal as well, so the clerk didn't say too much about it other than for now, we are not proper parties. You may want to call Lisa to confirm that is the case as well with the Governor, but I think it is.
