This office has reached a settlement with GlaxoSmithKline concerning the unfair and deceptive marketing of its drugs Paxil, Wellbutrin, Advair, Lamictal, Zofran, Imitrex, Lotronex, Flovent, and Valtrex. I am pleased to inform you that the portion of the settlement allocable to the South Carolina Medicaid Program is \$3,256,350.30. 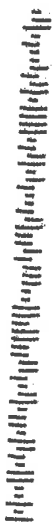
