Budget Update

The Appropriations Bill was Ratified on May 22, 2008 and sent to the Governor. The Governor’s Veto Statement was issued on May 28; vetoed items did ***not*** include any items which were funded for DMH. For the Department of Mental Health the following budget was adopted.

The Appropriation Bill also includes:

- A one percent increase for state employees and funds for the state insurance program so employees will not see an increase in premiums.
- A proviso that authorizes the Department to work with the State Treasurer’s Office on pre-funding options for the construction of a new child and adolescent hospital.
- A proviso that authorizes the Department of Corrections to use inmate labor for the construction of an annex at the Broad River Correctional Institute for treatment space and staff offices for the Sexually Violent Predator Program.

Senate Bills

S 190 Criminal Sexual Contact with Minors (Ritchie and others)

A bill to require the Department of Mental Health to establish a certification process for sex offender treatment providers and to provide that sex offender treatment ordered by the court or provided by the state must be provided by a certified treatment provider; and to provide that the Department of Mental Health convene a committee to study the Sexually Violent Predator Act to review and evaluate the operation and effectiveness of the Act and submit a report and recommendations to the General Assembly before January 1, 2009. S 198 Intervention by School Officials (Ritchie and others)

A bill relating to the offense of disturbing schools, to provide greater specificity for the types of conduct which constitute the offense and to provide for intervention by school officials prior to referring some cases to court (if a Team Intervention Committee is established, it could include someone from a DMH Community Mental Health Center).

Referred to Subcommittee on Judiciary; favorable with amendment.

S 353 (Companion Bill to H 3135) A Joint Resolution – Statewide Comprehensive Service Delivery System (Lourie)

A bill to establish a study committee to develop a statewide comprehensive service delivery system for persons with epilepsy in this state and to provide for the membership, duties, and responsibilities of the study committee. Requires a representative from the Department of Mental Health to serve on the committee. [View full text.](#)

S 372 Rules of Conduct for State Employees (Peeler and others)

A bill to provide that state agencies that serve as the primary host or sponsorship of an event are prohibited from obtaining sponsorships for the event, and defines specific terms. [View full text.](#)

Referred to Subcommittee on Judiciary.

S 392 South Carolina Illegal Immigration Reform Act (Ritchie and others)

This proposed bill will require that every public employer (such as the SCDMH) participate in the Federal Work Authorization Program to verify that those who do work for or receive benefits from these employers have a lawful presence; also, stipulates enforcement authority and penalties for not being in compliance. Passed both bodies and a conference committee has been appointed.

S 1011 Joint Citizens and Legislative Committee on Children (Jackson and others)

A bill to establish a Joint Citizens and Legislative Committee on Children composed of three members of the Senate, three members of the House, three gubernatorial appointees. The Director of the Departments of Juvenile Justice, Mental Health and Social Services would serve as non-voting, ex-officio members. The Committee would study issues related to children as determined by the Committee or as directed by the General Assembly. The Judiciary Committee amended the bill to include the superintendent of Education and director of Disabilities and Special Needs as ex-officio members; added reporting requirements; provided for per diem and mileage for committee members; and authorizes the committee to be funded via the General Appropriations Act or other sources. S 1168 Technical Changes and Corrections Relating to the Department of Mental Health (Peeler and Alexander)

A bill relating to service of process on the director of hospitals; dividing DMH into divisions; patient rights grievance procedures; deleting the provision requiring a medical division to be headed by a medical doctor; and repealing the section relating to the Mental Health Commission setting the salaries of officers and employees of mental health facilities.

House read third time and returned to Senate with amendments. Enrolled for ratification.

S 1174 Exemption of Homeshare Enhanced Respite Programs (Peeler and Alexander)

A bill to exempt Homeshare enhanced respite programs designated by the Department of Mental Health under certain conditions. [View full text.](#)

Ratified 5/15/08. R273. Signed by Governor.

House Bills

H 3024 Establishing the South Carolina Sunset Commission and Sunset Review Division of the Legislative Audit Council (Rice and others)

A bill to establish procedures providing for the manner in which the programs of certain agencies and departments of state government must be evaluated to determine if they should be continued in existence, modified, or terminated and to establish the procedures relating thereto. Referred to Committee on Ways and Means; favorable with amendment. Read 3rd time and sent to Senate.

Referred to Subcommittee on Judiciary.

H 3073 Restructuring Bill of 2007 (W.D. Smith and others)

A bill to establish the Department of Behavioral Health Services and to establish within this department the divisions of Alcohol and Other Drug Abuse Services, Continuum of Care, Disabilities and Special Needs, and Mental Health by transferring to the Department of Behavioral Health Services the operations of the Department of Alcohol and Other Drug Abuse Services, the operations of the Department of Disabilities and Special Needs, the operations of the Continuum of Care for Emotionally Disturbed Children from the Governor's Office, and the operations of the Department of Mental Health. H 3120 Determination of Capacity to Stand Trial of Persons Charged with a Crime or Civil Contempt (Kirsh)

A bill to provide a procedure to suspend and reinstate a person's driver's license or privilege to drive if the person is unable to stand trial because of a mental condition. [View full text.](#)

Referred to Committee on Judiciary.

H 3279 Establishing the Mobility Development Authority as a Division within the State Budget and Control Board (Scott)

This bill was amended to create a study committee to examine certain Mass Transit and Human Services transportation programs throughout the state. [View full text.](#)

Signed by Governor 5/14/08. R245.

H 3376 Moving the Care and Treatment of Sexually Violent Predators from the Department of Mental Health to the Department of Corrections (Lucas and Cooper)

A bill relating to the commitment, treatment, and periodic review of persons determined to be sexually violent predators to provide that the responsibility for the housing, control, care, and treatment of these persons is the responsibility of the Department of Corrections rather than the Department of Mental Health. H 3797 Licensure of Health Facilities (Chalk)

A bill to amend Section 44-7-130, Code of Laws of South Carolina, 1976, relating to definitions used in connection with the licensure of health facilities, so as to add a definition for an "in-home care service provider"; and to amend Section 44-7-260, relating to requirements for licensure of a health facility, so as to make the licensure requirements applicable to an "in-home care service provider." H 3879 Community Residential Care Facilities (Kirsh and Pinson)

A bill to amend Section 44-7-350, Code of Laws of South Carolina, 1976, relating to community residential care facilities, so as to provide that the Department of Health and Environmental Control may not remove a resident from such a facility if the resident, the resident's family, the resident's physician, and the facility agree to the resident's continued stay and if the facility is capable of providing or obtaining necessary services for the resident. H 3936 Reporting Death of Vulnerable Adults to SLED (White)

A bill to amend Section 43-35-35, as amended, Code of Laws of South Carolina, 1976, relating to requirements for reporting deaths of vulnerable adults to the Vulnerable Adults Investigations Unit of the South Carolina Law Enforcement Division, so as to exempt reporting deaths of vulnerable adult residents in nursing homes contracted for operation by the Department of Mental Health. ***H 3964 Concealable Weapons Permit (Duncan and others)**

A bill to amend the Code of Laws of South Carolina, 1976, by adding Section 23-31-250 so as to provide that a person who possesses a concealable weapons permit may carry a concealable weapon on his person while on the premises or property of a public educational institution.

Referred to Committee on Judiciary. An amendment was introduced in the House Criminal Laws Subcommittee on 5/16/07 by adding, in part: *Section 23-21-245. Notwithstanding another provision of law, if a person is involuntarily committed to the Department of Mental Health pursuant to Chapter 17 of Title 44, documents concerning the involuntary commitment filed with any department or division of the State, must be transmitted to SLED to be utilized by SLED when determining, pursuant to federal law or any other provision of law, whether a person is qualified to obtain a concealable weapons permit.*” [View full text.](#)

House recommitted to Committee on Judiciary.

H 4059 Optional Alcohol Exclusion Provision (Gullick)

A bill to amend the Code of Laws of South Carolina, 1976, by adding Section 3-71-380 so as to provide that the optional alcohol exclusion provision contained in certain insurance policies that require the replication of exact language as provided in Section 38-71-370 does not apply to a medical expense policy, and to define medical expense policy.

H 4400 Illegal Aliens and Public Employment (Harrell and others)

A bill to amend the Code of Laws of South Carolina, 1976, by adding Article 13 to Chapter 11 of Title 9, relating to illegal aliens and public employment. Would require SLED to sign an agreement with the Department of Homeland Security that would allow its agents to carry out federal immigration laws. [View full text.](#)

Ratified 5/29/2008. R327.

H 4737 Restructuring of the Department of Mental Health (Harrison)

A bill to restructure the Department of Mental Health into a Cabinet agency. This bill would provide that the director be appointed by the Governor and the Mental Health Commission would become advisory in nature. The Commission would consist of seven members appointed by the Governor with the advice and consent of the Senate. [View full text.](#)

House read third time and sent to Senate; Referred to Committee on Medical Affairs.

H. 4899 Creating a Committee to Examine the Delivery of Behavioral Health Care Services in South Carolina (Edge and others)

A Joint Resolution to create a committee to examine the delivery of behavioral health care services in South Carolina, and to report its findings and recommendations to the General Assembly by January 1, 2009. [View full text.](#)

Senate read third time. Returned to House with amendments.

H. 5012 Requiring Nurses to Wear Identification Badges (Chalk)

A bill to add Section 40-33-25 to provide that the Department of Labor, Licensing and Regulation may require state and national criminal records checks of an applicant for licensure to practice nursing; to provide that criminal checks may be done in connection with an investigation of disciplinary proceeding of a licensee; and to add Section 40-33-39 to require a licensed nurse to wear an identification badge bearing the nurses’ first or last name, or both, and title.
