Nickey, thanks for including me in this thread. I will add it to the irrefutable evidence I present in court against Skip on Tuesday. It is just further proof of how deranged he is. When I went to the court yesterday to file my perjury and contempt motions against Skip, I met with the Sheriff's deputy who heads security for the court building. I advised him that Skip has been convicted on two serious gun charges and showed him some of the recent threatening emails Skip had sent me. He agreed those simple facts raise his level of concern and security responsibilities for Tuesday. I think Skip is going to be quite surprised by the precautionary reception he gets upon arrival in court. In addition, I now believe I will indeed be able to get him "Baker Acted," meaning an involuntary hospital commitment for a 72-hour psychiatric evaluation. The standard here in Florida is among the lowest in the country and Skip obviously exceeds it by a country mile. Mr. Saunders:

I encourage you to read this email thread (below) from late Wednesday night/early Thursday morning. It goes to the heart of what caused Skip's mental meltdown over the past week.

He filed a false police report against me on Sunday for "aggravated assault." When that didn't fly, he filed a restraining order petition yesterday. He committed perjury in his sworn statement said he "fired" me and I am a "disgruntled employee." I have the "resignation" emails from all 5 times I quit, for the last time on September 21.

I did research yesterday as a reporter and found he has a criminal past, including a gun conviction in 2011 (trying to carry a concealed weapon on a plane at Savannah Airport). He was on probation for a year. In 2010, he got slapped with a \$215,000 IRS tax lien for unpaid taxes.

I am going to bury him by exposing him.

He declined a settlement offer today to simply withdraw the restraining order petition in return for me not filing charges against him for the false police report on Monday.

He also threatened twice to "take out" the HHI Town Council with a gun and both times I called Tom Gardo to express my concern.

Both times Tom told me he didn't think Skip would do it, but since last Friday he is in total mental meltdown, so I am filing a

complaint with the Beaufort County Sheriff in the morning with Tom as corroborating witness. Tom is no longer sue he won't snap and hurt somebody.
