
I showed them the unforwarded mail and told them what everyone had said, from the Mailman that delivered my mail to the staff from the Athletic department.

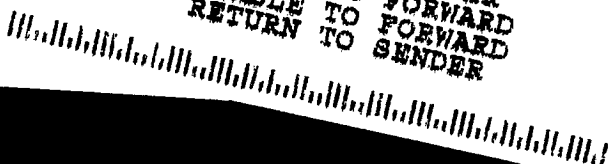
