Dear Senator Throckmorton,

I am a dad of a son who is mentally retarded and who has a life threatening seizure disorder. Jason Rush just turned 40 years old last Friday. Although he is retarded and has multiple handicaps, he is one of the kindest, thoughtful, and finest young men I know. I am proud to be his dad and only wish I could be as good of a man as he is.

Jason lives at home with his mom and me. His mom's health continues to deteriorate from a painful and debilitating condition to the point that she spends most of her time in bed now. All of my time is dedicated to taking care of my wife and son whose needs are complicated. They each have multiple doctor appointments, require many medications, and depend on me for assistance with their personal care, meal preparation, and the management of our home. I am currently in remission from cancer. Without the help I receive through Greenville County Disabilities and Special Needs Board for Jason, I would not be able to keep my little family afloat.

It is very important to my wife and me that Jason continues to live in our home. His doctors have told us that Jason's health is too fragile for him to attend a workshop or day program, and that he would not survive if he were placed in a residential setting. Our home is the safest and least restrictive environment in which Jason can live and maintain his best possible health.

I don't believe that most of our SC legislators understood the devastating impact that reducing funds for in-home care would have on families like ours when they approved Proviso 90.13. An amendment to Proviso 90.13 has been filed, and it is imperative that the General Assembly act immediately to approve this legislation. As I understand it, as a part of President Obama's Recovery Act, stimulus funds were given to SC Department of Disabilities and Special Needs to be used to continue providing in-home support services funded by Medicaid. The Proviso allowed 90% of these stimulus funds to be transferred by the State Treasurer in 2009 to the Health Care Annualization and Maintenance of Effort Fund, dubbed by many as the Rainy Day Fund. If Governor Sanford has his way, the same will happen to stimulus funds earmarked for SC DDSN in 2010. Conservative estimates have placed well over 100 million dollars in the Rainy Day Fund account, and this is a clear violation of the Recovery Act. Had these funds not been diverted there would not have been a need for devastating cuts in home based care implemented January 1, 2010. The public has been led to believe these cuts are the result of


insufficient funds in the state budget, but that is false. **Governor Sanford's actions have been illegal, immoral, inhumane, and fraudulent.**

Placing these funds in a Rainy Day account has resulted in putting our most vulnerable citizens at risk of being placed in residential facilities or day programs that are inappropriate. Many paid caregivers have lost their jobs. Restoring these funds will allow hundreds of mentally and physically disabled citizens for whom these funds were intended to remain in their homes to receive the care they need. In addition to being the least restrictive environment in which they can be served, it is also much more cost effective for them to live at home. Residential services cost about \$400 per day as compared to \$70 per day for supported care in the home. Many of these vulnerable citizens have families who love them and want the responsibility of caring for them. However, without support these families will not be able to continue to care for their loved ones at home.

Even if you do not share my Christian world view and believe as I do that "if you have done it unto one of the least of these, you have done it unto me", I hope that you do believe in the values of life, liberty, law, and ethics. I trust that you have a desire to live in a community of people who want to help those who cannot help themselves because it is the right thing to do.

**As our legislators, I am asking you to do the right thing. Vote to restore funding to our most vulnerable citizens by amending Proviso 90.13.**


