- Do you have a control total that shows what has been extracted and sent to Susan for a current day's A/R activity ie (daily RA90). If there is a control total, is there a criteria set at to if "grater than or less than" in order to catch items such as the \$62,000.00 that was omitted.
- What is being given back to you (ie a confirmation from Susan) as to how many \$\$\$ have been loaded into her billing, on daily basis?
- Do you know the next morning how many \$\$\$ did not make it in her billing system?

For Wanda to look at Daily RA90 and to inform you if something is wrong does not serve any purpose because you must compare what Susan had loaded in her billing to find your outages. USE OF RA90 BY ITSELF SERVES NO PURPOSE.

Currently RA90 does not show us the comparison of the two system A/R \$\$\$ on daily basis.  
Can you help us? Tejal

At any rate I just got off the phone with Susan, after hearing her dissatisfaction about our A/R process I informed her to e-mail you Rolf with any complaints.

Wanda in the future can you check your totals out of RA90 **daily**. If you don't have any, then is the time to let us know.
