



As requested the following Addendum is provided to the original Attestation Letter provided by William S. Hall Psychiatric Institute dated August 22, 2006. William S. Hall Psychiatric Institute is a Residential Treatment Facility licensed by the SC Department of Health and Environmental Control, License #011 for 37 beds.

As of September 10, 2006, there are 22 individuals currently served within the PRTF who are provided services based on their eligibility for the Medicaid inpatient psychiatric service for individuals under the age of 21.

At the present time there are no individuals whose Medicaid psychological services under the age of 21 that is paid for by any State other than South Carolina.

The PRTF has not received compensation nor billed for Medicaid payment from any State other than South Carolina.
