Thanks again for this.

Josh and I talked for a while over the past few days about working out a swap between the General Fund and the EIA in order to jump to the EOC model more rapidly. We think we might have something.

The short version is that we'd likely leave transportation in EIA (for now anyway) and would send the remainder of CDEPP and First Steps to the EIA, along with the Charter School District. We'd cut the High Achieving Students and Students at Risk lines significantly in order to get the EIA back into balance, but thanks to the transfers, we'd have substantial free cash available in the General Fund now in order to pay the transition costs (and to make hold harmless payments to the affected districts).

He spent the weekend using your spreadsheet to model it, while I kept pushing ahead with the very rough side-by-side we're working on for the bill.

It's not much notice, but is there any chance you have some time Monday to talk through some of this?
