Dear Susan: First of all, congratulations! When I went to email you, I saw that you were promoted to Deputy Director!.

I am following up about the HIV/AIDS prevention grant that we talked about a while ago. As you know, these things take a lot of time percolating through the NIH grants system, but we just found out that we were funded for our Phase 2 Study on "HIV/AIDS and STDs Prevention in Women over 50," with its focus on ethnic minority women.

As you might recall, in addition to the support you provided (through the letter of support you got from

Debbie Hammond), we are also working with Bambi Gaddist of the South Carolina HIV/AIDS Council and Carmen Hampton Julious of the Palmetto AIDS Life Support Services (PALLS), in addition to several others within the State to further develop our online website, to deliver easy-to-understand safe sex knowledge and skills to older women, particularly those from ethnic minority groups, who are at-risk for HIV/AIDS and STDs.

As a first step in launching the project, we are planning a major press event in South Carolina to launch the website and accompanying videos. We are thinking it might be best to have a mini-symposium and press event to jump start the project. We are hoping this will raise awareness about HIV/AIDS and STD prevention among this population group.

Before beginning to schedule the event, which we hope to have in either October or November, I wanted to find out your availability as we are committed to having your presence at the event. Your enthusiasm is infectious, and I know your being there will enable us to reach out to key stakeholders. I will have either Martha Norton or Jenny Lu contact you about your availability for such an event.

If you have additional people whom you think we should invite, please let us know.

I very much look forward to working with you and the Lt. Governor's Office on this exciting project. I remember how enthusiastic you were about the project, and am so happy to be able to get back to you with our next steps in moving forward. Thank you again, and I very much look forward to working with you so that we can together make a significant difference in the reduction of HIV/AIDS and STDs in older women in South Carolina.

> Dear Ms. Hammond: I greatly enjoyed meeting you at the Steering Committee meeting of the South Carolina ADRCs. After the meeting, Susan Theriot and I talked, and have had subsequent conversations about the potential for a collaboration between the Lieutenant Governor's Office on Aging and the work that we are doing in the area of HIV/AIDs prevention in women over 50. As you well know, the statistics are alarming, with HIV infections rising among women over 50, with African American women most at risk. We have developed a multi-media, web-based safe sex education program with NIH funding, and are now submitting a Phase 2 NIH grant to expand the content and to develop ways that the material, including videos, and risk assessment tools, can be utilized by agencies that provide information and referral to older adults. We very much look forward to working closely with the Lieutenant Governor's Office on Aging in its efforts to reduce the incidence of HIV/AIDs in women over 50 throughout the state of South Carolina.
