Mary Lou Leary Appointed as ONDCP Deputy Director for State, Local, and Tribal Affairs

The Office of National Drug Control Policy is pleased to announce the presidential appointment of **Mary Lou Leary** as Deputy Director for State, Local and Tribal Affairs. Ms. Leary brings to ONDCP more than 30 years of criminal justice experience working closely with states, local governments, and community stakeholders. Ms. Leary replaces Benjamin Tucker who left the Obama Administration to work for the New York City Police Department.

Ms. Leary previously served in the Department of Justice and the U.S. Attorney's Office for the District of Columbia. She received a B.A. from Syracuse University, an M.A. from Ohio State University, and a J.D. from Northeastern University School of Law.

Border Protection.

ONDCP and DEA Host Disposal Webinar

On November 6, the Office of National Drug Control Policy joined the Drug Enforcement Administration to host a webinar for community agencies, coalitions, and governments looking to implement drug disposal programs. Safe, environmentally sound disposal of prescription drugs is one of the four pillars outlined in the 2011 *Prescription Drug Abuse Prevention Plan* to reduce prescription drug misuse in the United States. Officials and disposal experts from Alameda County, California, also joined the webinar to discuss how ordinances might define and fund programs at the county level.

Innovative CMS Program to Focus on Substance Use Disorders

The Centers for Medicare & Medicaid Services (CMS) recently launched the Medicaid Innovation Accelerator Program (IAP) to improve care, improve health, and reduce costs. The IAP will support efforts to accelerate Medicaid innovation by offering states technical assistance and other resources. Based on work with states and stakeholders, CMS has identified substance use disorders as an area of focus for IAP efforts, pointing out that “[N]early 12 percent of adults in Medicaid and 6 percent of adolescents have a Substance Use Disorder or issue. Further, Medicaid beneficiaries with alcohol or substance use diagnoses are two of the top ten reasons for hospital readmissions.”^[i]

As part of a strategy to improve the care and outcomes for individuals with such disorders, the IPA issued an information bulletin on October 29. The bulletin invites states to leverage IAP resources to introduce system reforms that better identify individuals with substance use disorders and expands coverage for their effective treatment.
